ASSIC's future still unclear

Unwilling to take "No" for an answer, members of the Halton Hills Multi-Service Agency (MSA) Committee are searching for ways to convince the Minister of Health that a local, not regional approach is needed for elderly and disabled long-term care in Acton and Georgetown.

Members of the Halton Hills MSA are both frustrated and worried by a recent decision by the Halton District Health Council (HDHC) to recommend to the Minister that a central Multi-Service Agency (MSA) with four service areas to provide long-term care, be established in Halton.

More than 75 Acton and Georgetown service providers and users attended the meeting in hopes of persuading the HDHC to accept a home-grown solution for long-term care.

Helen Dubeau of Acton, chair people who "could help" influence the Province.

"We haven't given up," Dubeau said in a recent interview.

"There's a lot of community interest in keeping local control of these services.

"I stood in my own church to say thank you for the support we've received on this issue and was told to keep going and not to give up," Dubeau explained.

Dubeau, a volunteer with Acton Support Services and Information Centre (ASSIC) for 18 years and a

service consumer, said the future of ASSIC is uncertain because "a Regional MSA will decide where the dollars go and our money could be reduced." -

Acton's Lorne Doberthien, president and chair of ASSIC, said the decision to go with a central MSA and Community Health Centre in Halton Hills is disappointing and a tragedy.

"If the Minister of Health approves a central MSA we really don't know what is going to happen as far as Acton is concerned," Doberthien said last week.

"In effect, the Health Council is trying to tell us what is good for Acton, but ASSIC's success has ran it and kept it going for Acton.

"The main thing is that we want Hoff said.

"We see this (a central MSA and Community Health Centre) as being a hornet's nest down the road or the gradual demise of ASSIC."

When asked about the future of ASSIC, HDHC interim Executive Director David Hoff said that it's premature to talk about operational issues.

I commend the work of Rick Bonnette, who was behind the scenes working with Mr. Dawkins and Mr. Bryson of the olde Hide House, my new landlords.


