## Light timers a key to savings

Actonites who leave their Christmas lights on day and night are not only burning them for no one's benefit, but are also burning a hole in their wallet, says a Halton Hills Hydro official.

"Festive lighting should be turned on after 7:30 pm and off before bedtime," Hydro's supervisor of customer service George Herrington said last week, adding people who don't could be in for a rude awakening come their next bill. "By adding a timer and having the light controlled automatically, there's more savings.

"Even if we get 10 per cent of Halton Hills residents to use a timer there will be a considerable difference."

Halton Hills Hydro insists on people using five-watt bulbs for outdoor lights rather than the standard seven-watt variety. One fivewatt bulb operating four hours per day for a 30-day period would cost approximately five cents a month.

"It can make all the difference between night and day," said Herrington, who makes his halfwatt pin lights outside his home more attractive by using a musical timer to have them flash to different beats.

There is a period each day, known as the peak period, when Halton Hills residents use the most electricity at the same time. In the winter, this occurs between 8:30 am and 2 pm.

Since Halton Hills Hydro's supply of electricity has to accommodate peak demands, the higher the peak is, the more hydro customers pay for their electricity 24 hours a day, 365 days of the year.

"It's easy to bring peak electric-

ity consumption down," said Herrington. "Just break a few old habits or form a couple of new

Besides switching to low-watt Christmas bulbs, Herrington suggests you take the heat off your water heater. Wait until after 7 pm or 7:30 pm to use your dishwasher or to take baths or showers.

"If you start your wash after the electrical rush hour, you'll still have plenty of time to finish it before bedtime."

And when the deep cold hits Acton and your car won't turn cost would hover around \$7.20. over in the morning, think of purchasing a timer for your block heater.

A timer — Herrington says one

can be bought for \$40 — will turn on your block heater when it's needed, a few hours before you awake. The savings that result from reducing time to heat your car can offset the cost of buying a timer over a year.

Using a 1000-watt heater they range from 750 to 1,500 watts

—Herrington points out that having it plugged in every night for a month would cost one about \$26.40. However, if the timer is set to heat the car from 3 am to 6 am — all that is required — the
