Heaton goes into hiding as company begins legal action

Rural rep runs from Blue Springs warning

A frustrated process server, working for Blue Springs Golf Club's lawyer, was unsuccessful in his attempt to give legal papers to a Halton Hills Councillor on Monday night.

The server was told to leave the Council Chambers by General Committee Chair, Councillor Norm Elliott, when he tried to serve Councillor Rob Heaton with some legal documents during the meeting.

When Heaton saw the man coming toward him he quickly pro-

Several minutes later Heaton slipped out of the Chambers and disappeared, leaving the server staking out the parking lot and several front entrances at the Civic Centre.

Tannery no worry to police, Town staff

Town staff have not decided if any notices of property standards violations will be issued against owners of the old Beardmore tannery.

Following a site tour on Thursday with police and fire officials, Town staff reported there were a few violations on the abandoned property, but they are being fixed.

"Basically, an abandoned structure must be boarded up and sealed until it is repaired or demolished," explained Town enforcement officer Ron Stein on Friday.

"The owners are making efforts. They have a full-time custodian who tries to keep the place boarded up."

The issue of safety at the site was raised by several Acton councillors, who reported that vandals had trashed the buildings and in one case, set a fire.

Stein said the owner, Maple Leaf Mills, which was recently purchased by McCain Foods, is cooperative and willing to work with the Town and other agencies to secure the site.

"There probably isn't even enough additional boarding up to be done for me to issue and order," Stein said.

"The only purpose for me to issue an order would be to ensure that they would continue to maintain the site until it is repaired or torn down. To me, it's a pretty good site, even though kids are getting in and causing problems."

Stein said the Town might wait until the owner is not maintaining the site before issuing any property standards violation notices.

Halton Police Detective Sergeant Roy Smith, who toured the site last week, downplayed problems with the property.

"We don't have a lot of problems there, but some people are making it an issue. I don't see it as a crying problem at the moment," Smith said.

"There's no question that there are problems with vandalism and trespassing but they are education and enforcement issues that we will deal with."
