# Golf club to sue Counc. Heaton

Rural Councillor Rob Heaton has not responded to a request for an apology and retraction and so will be sued under the Libel and Slander Act by the owners of Acton's Blue Springs Golf Club.

Springs warned Heaton if he did not issue a "clear and unequivocal apology and retraction" within 10 days of being served with the notice, a statement of claim naming him as defendant would be filed.

June 2, a lawyer acting for Blue '8 Council meeting when he said: "It's also come to my attention that there's some Town letterhead bouncing around out there in the public domain, with three councillors and the former mayor's signature concerning this property that as well."

Blue Springs presently has an application before the Town for three club houses with 120 overnight accommodation units at the golf course.

In the letter to Heaton, Blue Spring's lawyer V. William Andreou said there were untrue, disparaging and defamatory imputations in Heaton's comments, which were directed at his clients and reflected on their personal, business and professional reputations. He claims they amount to a very serious libel.

Although the deadline for a response from Heaton passed almost two weeks ago, Don Dawkins said on Monday that they had not




