Re-try Homolka

(Editor's Note: The following letter recently was sent to the Provincial Legislature. It was submitted last week to The Acton Tanner for publication.)

Dear Conservative Member of the Provincial Legislature:

Now that the Crown has dispensed with testimony from Karla Homolka in her husband's trial, I urge you to insist that your new Provincial Attorney General cancel her plea bargain and commit her to a new trial.

Evidence presented at Paul Bernardo's trial more than amply provides proof that she did not bargain in good faith and that the plea bargain was obtained under false pretenses. For example:

- She was intimately involved in the assault on Jane Doe as depicted on video, regardless of her

assertions that she has no memory.

- She is clearly, directly responsible for the death of her sister through the administration of a lethal substance.

- According to her husband, she may be the actual killer.

Further, Judge Kovacs erred in condoning a light sentence for such serious and horrific crimes. Conveniently, he announced his retirement from the bench the day before Homolka started testimony. Coincidence or face-saving?

Ontarians are shell-shocked and embarrassed at the way this case was mis-handled by the former government. The Harris Common Sense Revolution should be, and is, in a position to fix this wrong.

I urge you to act in the name of justice.

To the Editor,


The Halton Hills Public Libraries are celebrating their 100th anniversary, and we need your help! The search is on for former employees of both our Acton and Georgetown branches.

To be a part of this special occasion, past employees, board members or family members are invited to call Geoff Cannon at 873-2681. Let's celebrate together!


