MVA taxation a 'bonanza' for Acton

Most Acton homeowners, farmers and industries will pay less in Regional and school board taxes next year as Halton Hills comes up the big winner in the Region's move to Market Value Assessment (MVA).

The major adjustment of the taxation system puts every property in Halton on equal footing for taxation purposes, so properties of similar value are taxed at similar rates, regardless of where in Halton they are located.

"The overall picture for Halton Hills is a bonanza," a happy Acton Councillor Rick Bonnette reported in an interview on Friday.

"This is the biggest break Halton Hills has had since it joined Regional government and although some Acton property owners will

pay more next year, most will pay less," Bonnette explained.

Halton Hills will pay \$2.2 million less to the Region, Milton's tax levy basically remains the same, Oakville will pay \$1 million less, but Burlington taxpayers will get hit hard and have to pay \$3.3 million more to Halton.

Regional Council received the MVA impact figures last Wednesday-figures resulting from a compromise deal spear-headed by Bonnette to have 1992 used as the base year for assessing value, not 1988 levels as first planned.

"The picture is better than I thought it would be," Bonnette said, as he explained that he would support a phase-in program for anyone whose taxes will increase home owners, whose taxes will

will see the biggest tax savings with 85 per cent of 668 farm properties paying less next year.

Fifty-seven per cent of local industries will also have a smaller tax bill next year and 61 per cent of commercial properties will pay more. All multi-unit residential properties in Halton Hills - those with more than seven units - will pay more in taxes than this year.

Town Treasurer Andy Koopmans said property owners can call the Town or the Assessment Office to learn what MVA will mean for them.

"Market Value Assessment is good news in total for Halton Hills, but I say that cautiously because it is not good news for 41 per cent of

A small sampling of Acton homeowners showed a tax decrease of \$109 for a home in the Bovis subdivision, a \$190 tax decrease for a Dublin Line home and a \$30 decrease for a 2-year-old Pearl Court home.

A check of three Acton businesses showed two would have tax decreases of \$1,209 and \$1,927 and one would have a \$45 jump.

Of the two Acton industries surveyed, one would have a \$6,700 decrease in taxes next year and one a \$2,832 decrease.
