Can't-miss courses!

If you've been thinking of signing up for an instructional class this fall, for yourself or for your children, look no further than your Rec and Parks brochure.

Information on everything from Aikido to 'Y' programs can be found in the booklet. Dance, music, sports, fitness classes, computer training, swimming lessons and crafts are just a few of the highlights.

One glance through the brochure and you can't help but realize what a diverse and interesting group of people we have living here in Acton.

More advanced students could study the notion that the *empty* milk bag can go in the garbage, to be replaced by a *full* bag, which, of course, goes back *in* the fridge.

Then there are those difficult words "before" and "after." This takes a lot of self-discipline to fully understand – as in "You may watch TV after you get your homework done," and "before dessert you must finish your vegetables."

The natural progression, after completing Small Words; Difficult Concepts, would be the more advanced Tough Jobs Made Easy. This seminar would cover such complicated tasks as Putting the Cap on the Toothpaste, Helping to Bring in the Groceries, Taking the Dog for a Walk – and I, myself, would be willing to teach the lesson on How to Replace the Toilet Paper Roll.

Watch for registration info. If they ever materialize, I have a feeling these classes would fill up in a hurry!


We didn't win the event, but the *Tanner* team of rowers came up with a big effort in the first annual Crazy Canoe Relay Race at the fair on Saturday.

Parents responsible

To the Editor,

I am writing in response to last week's article in *The Tanner* about bussing 3-year-olds.

Children have been walking to and from school for many years. I will agree that a 3 or 4-year-old is not able to walk alone, but then neither are 5-year-olds.

Parents have managed this task for years. It is a parent's responsibility, not the taxpayer's. If you are not eligible for the busing service, then be prepared to pay.

Let's all go back three years, when it was decided that it was costing too much money to keep a crossing guard at two of the busiest crosswalks in town over the noon hour.

This decision left our Kindergarten children unattended while crossing Hwy. 7. Parents had to deal with this on their own. Isn't it time we took some responsibility for our children?

With regard to Junior Kindergarten and the overcrowding in the classroom, being a certified E.C.E. teacher, I will agree that a teacher-student ratio of 1:25 is too much to manage. However, if parents had investigated thoroughly before enrolling their child in J.K., they would have seen that.

Nursery schools are governed by the Ministry of Social Services and have very strict regulations, one of them being a ratio of 1:8. J.K. follows the guidelines set out by the Board of Education, allowing for a ratio of 1:25. Both programs deal with children of the same age, but there is a difference!

A visit to any nursery school will show you that a smaller ratio is more beneficial. There is one important difference that we should not forget—nursery schools require that you pay for your child's pre-school experience; with J.K. we all foot the bill.

J.K. is an optional program. If parents want a smaller teacher-student ratio in the classroom, they should have enrolled their children in the Acton Co-op Nursery School before it was forced to close its doors.
