PUBLIC INFORMATION MEETING

Review of Development Charge Policies Oct. 16, 1995, 6pm • Council Chamber, Civic Centre

Background: Town Council passed By-laws No. 91-170 and 91-171 on Oct. 28, 1991, which enacted development charges and policies pursuant to the Development Charges Act. These by-laws expire on Nov. 15, 1996 and, accordingly, the Town is initiating the process required to replace them. Section 6 of the Act requires Council to conduct a review of the development charge policies of the Town, before passing new development charge by-law(s). In conducting this review, Council is required to ensure that adequate information is made available to the public and to hold at least one public meeting.

Meeting Purpose: This meeting is being held in order to:

· inform the public as to the Town's current development charge policies;

· obtain public input relative to preparing new policies; The meeting will not deal with growth-related net capital costs which may subsequently comprise revised development charges. These will be the subject of a

· review the proposed process for the adoption of new by-law(s) in 1996.

subsequent public meeting in 1996. Members of the public will be given an opportunity at the meeting to make representations regarding the Town's Development Charge policies.

Available Information: To ensure that adequate information is available to the public, a background document will be available upon request, as of Oct. 2, 1995 from the Treasurer. As well, copies will be made available at the public meeting.

Submissions: Comments expressed at the public information meeting or received in writing by the Treasurer, within thirty (30) days of the public meeting, will be considered in this review and the subsequent preparation of the Town's development charge proposal.

Comments or Requests: Any comments or requests for further information regarding the review of the Town's development charge policies may be directed to Mr. Andrew Koopmans, Treasurer.

Business group is put off

The Acton Business Improvements Area's (BIA) request for the Town to pay half of a proposed \$300,000 downtown core revitalization project was deferred by budget committee members at a meeting last Tuesday.

After hearing the BIA's proposal and comments from some councillors who questioned the request, Acton Councillor Rick Bonnette asked that the issue be deferred until the Council representative on the BIA could take part in the debate.

In making his pitch to the budget committee, BIA spokesman Gord Chapman said he hoped the engineering costs for the project, approximately \$10,000, would be included in the 1997 budget forecast and money for the actual project would be included in the 1998 budget forecast.

Chapman said the BIA would pay half the engineering costs and raise its half of the project (\$150,-000) through a long-term loan.

The BIA proposal includes a major facelift for the core with more green space, pedestrian cross-overs, planters and benches.

"We don't want to be left behind as Acton grows," Chapman said. "We want to grow together and we think it is important that the Town of Halton Hills share with us in this project."

Responding to questions from councillors, staff said that the Georgetown core face lift was paid for by a long-term BIA loan, with no Town money and that the Acton BIA recently repaid \$150,000, which was used to improve parking, street lighting and other renovations to the core area.

Acton Councillor Norm Elliott said he would be willing to include the engineering costs in the 1997 budget forecast, but not money for the full project in 1998.

"I'm sorry, I can't - there will be another forecast meeting in 1996 to ratify the capital forecast – but, I can't vote on that (the 1998 request)," Elliott said.

"There's never been a grant given to either BIA that was an outright grant."

After Councillor Moya Johnson also said she had reservations about a grant, but would consider a loan, and Mayor Marilyn Serjeantson asked about government subsidies, Chapman made a clarification.

"We're not asking for a grant. We are asking that the Town undertake the project, just like any other project," Chapman said as he pointed to the long list of other proposed projects in the capital budget forecast.

"We don't want to manage it, or get the money. Just so you understand, it is intended to be a project, that we thought would help the Town, to which we would contribute," Chapman said.

Bonnette asked for the deferral saying it was a very important issue - one in which Councillor Gerald Rennie should be involved.
