## Acton omitted from Yellow Pages' listings

Some local merchants are angry over the recently distributed Bell telephone book for Halton-Peel-Dufferin Regions and surrounding area, wondering why Georgetown is the sole community listing at the top of each Yellow Page.

Last year's book by Télé-Direct Publications Inc. dated February 1996 to 1997 listed *Georgetown*, *Acton* at the top of each yellow page and Halton-Peel further back in the regional listings.

Joe Adamo, a marketing manager at Télé-Direct's Montreal office, says a number of communities requested that their town have a listing at the top of each page. But Télé-Direct isn't able to accommodate everyone, so they felt the best solution was to streamline each book with a more general directory title.

"To meet the needs of everyone would have meant an exhaustive listing. In our eyes we haven't done anything wrong," contends Adamo, who adds Télé-Direct is redesigning all books this June. "The content of Acton businesses is very much noticed and in no way has the delivery area for the book changed.

The concerned merchants include Jake Kuiken (Halton Hills Furniture and Appliances-Clocks and Curios), Rob Charette (A Touch of Class-Lakeview Flooring) and Andy Katsilieris (Andy's Family Restaurant). Janis Fread has sent a letter to Charette on behalf of the Acton BIA stating "it's unacceptable that Acton was left from the listing."

What irks Kuiken, Charette and Katsilieris, is the fact Georgetown was used and not Halton Hills.

"It's a serious error. It should have said Halton Hills," says a visibly miffed Kuiken, who's thinking of with-holding payment on his \$37 monthly bill for a two-inch by two-inch ad if no changes are made. "Télé-Direct should be on the hook for this, especially since we're in different area codes."

Answers Adamo: "I've heard of that name (Halton Hills). But you have to appreciate a lot of (the final decisions) are done with local input. As to why Halton Hills wasn't used, I can only say that it probably wasn't suggested. We try to be responsive to all requests, so if Halton Hills is the preferred and accepted version we will go with that. I will make note of it."

## Councillors to oppose disposal site

Town councillors will formally object to plans for a waste transfer station on the old Ajax site on Queen Street in Acton. Tri City Services Ltd. operates a used tire recycling business on the site and has applied to increase the number of tires it is allowed to handle and store.

Although staff reported that there are currently 20,000 used tires on the site, Tri City president Mike Foley said that there are 5,000 tires on-site and the application would

allow him to store up to 20,000.


Town staff recommended councillors not object to the plans, but on Monday night General Committee members voted to inform the Ministry of Environment that because the site abuts a residential neighbourhood and is not part of the Town's vision for the gateway to Acton, it does object to Tri City's application for a certificate of approval for a waste disposal (transfer) site.

Tri City, which leases the site from Freure Management, collects used tires and exports some of them

to South American and Caribbean countries and recycles the rest.

Acton Councillor Rick Bonnette said he had a real problem with not objecting to the proposal to expand the business because the Town just finished an expensive Ontario Municipal Board (OMB) hearing, which ruled the site would be re-zoned to allow a commercial plaza.

Although the site could be zoned commercial, Town Engineer Bob Austin said the owner isn't putting any money into the property until finding a tenant willing to develop it.
