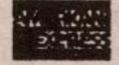

This year's capital budget includes \$100,000 for the project, which will include a box culvert under Mill Street, new stoplogs and fencing to make the site safe and attractive, including a barrier around the top of the bank.

Staff is making arrangements for a public information meeting to get input on the plans, and the consultant is working on construction drawings and specifications.

Asked about the seemingly low-tech proposal, Shynal pointed out that "sometimes simplicity is elegant and very functional."

Acton's Early Days reports that the mill dam was completed in the 1830s by backing up Black Creek until it covered 88 acres. It was originally called the Mill Pond until the turn of the century, when a local citizen thought the lake needed a more dignified name.

# Dawkins development

The Dawkins development, a 91-lot subdivision south of Commerce Crescent and west of Wallace Street, is one step closer to reality with Town Council's approval of a pre-servicing deal for Phase I, which is 60 homes.

As part of the deal the developer will oversize part of its storm water pond and pipes to allow the Town to use the facilities to drain storm water from the Commerce area, which has drainage problems.

The total cost of the oversizing is \$220,000 and the Town will repay Dawkins \$180,000 for its portion of the extra cost to oversize with the developer paying \$36,000.

## Rural estate plan delayed

A developer who "ran out of time" to meet conditions to register his proposed rural estate subdivision on Hwy. 25 at the Erin-Halton Hills Town Line has one more year to get the work done.

After being told that the economy has put most rural developments on hold, Town Council agreed not to oppose the developer's request to Halton Region to extend the draft subdivision approval for 20-lot Halton Green Estates, which lapses Oct. 19.

Town staff said that a draft subdivision agreement has been prepared for the Debryn-Pecan land and engineering drawings are almost done.

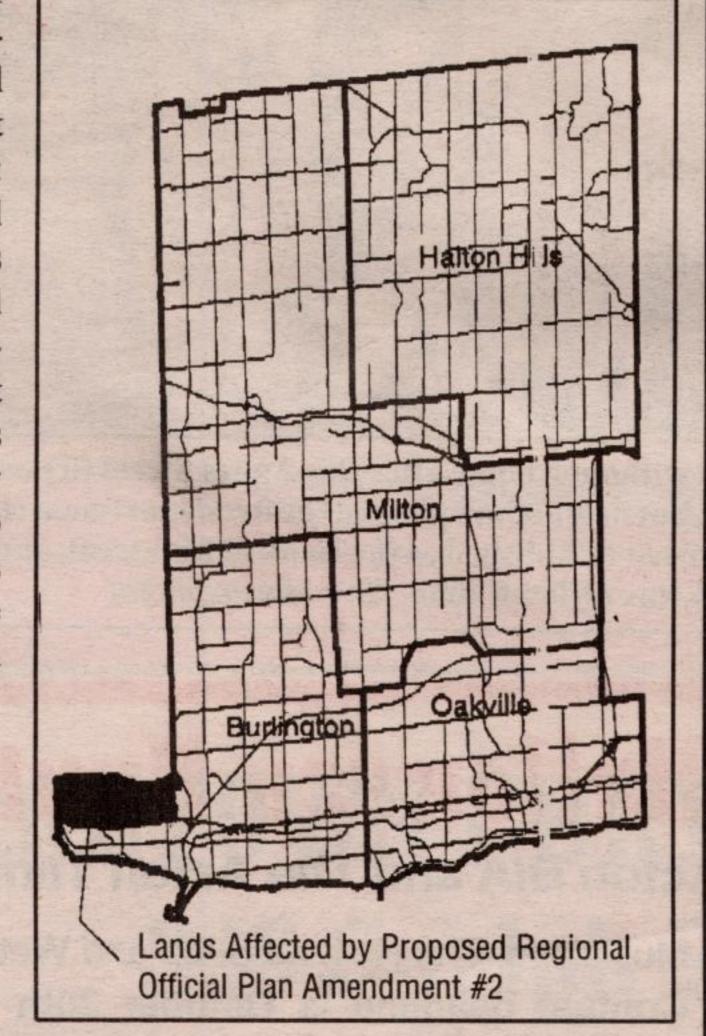

If a person or public body that files a notice of appeal of a decision of the Regional Municipality of Halton in respect of the proposed Official Plan Amendment does not make oral submissions at a public meeting or make written submissions to the Regional Municipality of Halton before the proposed Official Amendment is adopted, the Ontario Municipal Board may dismiss all or part of the appeal.

Related Applications: The City of Burlington is also proposing an amendment to the City of Burlington Official Plan for lands known as the East and West Sectors of North Aldershot (City File: 505-03-131). Lands known as the Central Sector of North Aldershot, includes lands subject of a City of Burlington Official Plan Amendment (City File No. 505-02-197), an amendment to Parkway Belt West Land Use Regulation 482/73 (Minister's File: 24-ZO-041-9203)), zoning bylaw amendment (City File 4000-841), and two plans of subdivision (Region File No.s 24T-94010/B and 24T-94012/B), and are the subject of an Ontario Municipal Board hearing for which a decision is pending.
