# Local lawyer files suit against Wiarton Willie

Claiming that Wiarton Willie – the albino groundhog that predicted spring was just weeks away – intentionally misled the public, Rockwood lawyer Doug Black has filed a class action suit against the woodchuck soothsayer who has come out of his burrow each February 2 for 41 years to predict how much longer winter will last.

"Willie intentionally misled a group of Rockwood residents into believing that spring was imminent," Black explained on Friday, "and he's going to pay."

Black said compensatory damages include the inflated price of summer wear caused by the rush of demand, along with medical and dental costs.

"One member of the group involved in the suit donned his new bathing suit upon hearing Willie's news and dove into the swimming pool," Black said. "When the family peeled him off the ice, he was missing most of his upper teeth and his million dollar smile was ruined."

Another woman told Black she was ashamed when she walked into the hardware store in shorts and bare feet looking for suntan lotion only to be told that Willie's weather prediction was a hoax.

Black said it was clear to him that "somebody has got to pay" when he stepped outside to head for work last week and found that the minus 25 degree weather was anything but spring-like.

"I thought something's


wrong and as lawyers do, started looking for defendants," Black said, tongue firmly planted in his cheek.

"Notice how Wiarton Willie disappeared right after his prognostication. He knew what was coming and that's part of the reason for the punitive damages – this was next to a fraud, almost. The misleading was intentional and Wiarton Willie was laughing on television."

Black said the suit faces two problems—first, Wiarton Willie must be found and served with the papers and secondly, there's the matter of assets because the groundhog has none to speak of.

"It is possible that Wiarton Willie is even owned by Environment Canada and the evidence is that Environment Canada, feeling the heat from terrible weather forecasting, put Willie up to this in return for a never-ending supply of lettuce. This is conspiracy and makes punitive damages all the more appropriate," Black said.

Officials at Groundhog Central in Wiarton had not responded to news of the class action suit at press time.
