



#### Message from the Chairman

**GROWTH IN HALTON HILLS** TO CONTINUE WHILE REGION SEARCHES FOR NEW WELL

Halton Region's growth initiatives were the focus of much publicity recently. In October, the Region proudly hosted two groundbreaking ceremonies. The first was the construction of the "Big Pipe." The second was the start of construction for the new Hwy. 407. Together they form the infrastructure cornerstones that will support growth and development in Halton for the next 20 years.

Another project taking place to meet the growth demands in Halton is the search for a well, capable of replacing the Region's Test Well 15 (Georgetown). Test Well 15 was to be the next well the Region planned to bring on-line to accommodate the equivalent of approximately 3,000 single detached units in Georgetown. However, when recent tests showed pumping from this proposed well would harm an adjacent wetland, we decided to find another well. While Regional staff are cautiously optimistic a new well can be in production in a time frame which will not adversely impact on growth in Georgetown, the amount of time it takes to find this well is a source of concern for both Georgetown residents and developers.

Because it could take up to two years to assess the well's capabilities, the Region must defer draft approvals of new subdivisions and significant infilling in Georgetown. Draft approval gives the landowner the right to pre-sell and pre-service lots. While this deferral may concern some residents and developers, Halton staff are working hard to find another well. In the meantime, there's sufficient existing ground water service capacity to allow for seven to eight years of real growth including the industrial, commercial and institutional development in the Town of Halton Hills. Put another way, the relative abundance of groundwater in existing Georgetown wells will enable registration of 96 per cent of the potential dwelling units in current draft approved subdivisions.

I want to reassure Georgetown residents that the Region's search for more groundwater does not include the option of bringing lakewater to Georgetown. In fact, the Region's Georgetown Water Supply Master Plan calls for a phased introduction of a series of wells to supply Georgetown. If the Region is unable to find an alternative to Test Well 15, the Region has other well options in the vicinity of Huttonville and Sixth Line. In order to continue to meet the needs of the community, Regional staff have embarked on an update to the Georgetown Water Supply Master Plan under the Class Environmental Assessment process. Over the coming months Regional staff will be working with the Town of Halton Hills to ensure that the results of the Region's search for an alternative to Test Well 15 are shared with the community at the earliest possible date. In addition, Regional and Halton Hills staff will be consulting with the community, on the Georgetown Water Supply Master Plan update.
