**CAPITAL PROJECTS:** Council approved a Capital Budget of just over \$13 million dollars, approximately double of last year's capital budget, reflecting the impact of growth related projects and improvements to the roads network, recreational facilities, library, and the fire department. The increased budget is not expected to significantly affect taxpayers, with the increase largely covered by development fees and revenue from the Ontario Lottery Corporation. "Slot Revenue" allows for capital



## JOINT PUBLIC INFORMATION SESSION NOTICE

### REGARDING APPLICATIONS BY DUFFERIN AGGREGATES FOR A QUARRY EXPANSION

**WHEN: Tuesday February 13th 2001, 6:00pm to 9:00pm with a presentation at 7:30 pm**

**The proposal pertains to a request for approvals to allow aggregate extraction of an additional 83 ha (205 acres) of land adjacent the Town Line in Part of Lots 12-14, Concession 7 (Nassagaweya) in the Town of Milton and Part of Lots 13 and 14, Concession 1 (Esquesing) in the Town of Halton Hills**

**Explanation**  
This Joint Public Information Session will be attended by staffs from the Niagara Escarpment Commission, Ministry of Natural Resources, Regional Municipality of Halton, Town of Milton, Town of Halton Hills, and Conservation Halton in co-operation with Dufferin Aggregates representatives. In addition to information on the proposal being provided by Dufferin Aggregates, agency staff will provide information relating to the processing of recent applications for a Niagara Escarpment Plan Amendment, Halton Region Official Plan Amendment, Town of Milton Official Plan and Zoning Amendments, Town of Halton Hills Official Plan Amendment, and a proposed Ministry of Natural Resources Aggregate License. It should be noted that this session does not represent statutory meetings under any applicable Act.
