Speed, Traffic, Safety - major concerns on Guelph Line

When the "under construction" signs appear, Brookville parents are hoping to ensure the short-term inconvenience will be beneficial in the long run.

About 40 to 50 concerned residents attended a second public information meeting regarding the 2004 reconstruction of Guelph Line, between 15 Side Road and 20 Side Road, held on Tuesday, February 26, 2002 at the Nassagaweya Community Centre.

Its purpose was three-fold: to describe the work on the study which had been done to date; to present the preferred design choice for the improvements; and to obtain input from the public.

Although there are drainage and pavement problems with Guelph Line in the study area, vehicular speed, the amount of traffic through Brookville and potential safety issues, particularly around Brookville Public School, were the main concerns.

Many community members feel there's a need for traffic lights at 20 Side Road.

According to iTRANS

Consulting, the intersection did not meet the criteria for recommendation of a traffic light.

iTRANS is recommending the road be widened and proper shoulders be created in the rural area to help alleviate some of the traffic problems. They are also proposing a left hand turn lane be added on Guelph Line at 20 Side Road.

A discussion ensued about the use of 20 Side Road as an alternate to the 401, especially when there are accidents or slow-downs. If a traffic study were done during one of these times, the results might be very dif-

Jim Horton, of iTRANS, suggested the public put their comments forward for consideration and they would be reviewed.

"It is well known that 20th Side Road is a northern corridor used as an alternate to the 401," said Regional Councilor Barry Lee.

He suggested iTRANS put more effort into reviewing this intersection, specifically at times of congestion on the 401.

A comment was also made that the study conducted on the intersection at 15 Side Road and Guelph Line initially did not show a light was warranted. However, the community pushed for it, and there is now a light at that intersection.

Traffic at Brookville Public School, especially during bus times, is a major concern, iTRANS met with Halton District School Board representatives on Thursday, February 21 to discuss the concerns.

Brookville Principal Rick Nodwell identified parking for parents, and allowances for student drop-off and pick-up as a concern that he is addressing with the board. Although it is not part of the study, Mr. Nodwell did state that he is working with the School Board to get an overflow parking area identified at the school.

"I have identified this as a priority to both the (Nassagaweya Community) School Council and the Halton District School Board," Mr. Nodwell said. "But it has to go through the School Board's Capital Improvement Project."

The discussion about traffic at the school also turned to the issue of speed. Matt Krusto, from Halton Region, said the Region has an annual review process in place for addressing issues related to Speed Limits.

Guelph Line between 15 Side Road and 20 Side Road, particularly in the area of the school, is already scheduled to be reviewed this year. The study will look at the operating versus posted speeds in the area, as well as the number of high-speed collisions.

After a recommendation made a year ago, this area is already one of the most enforced areas for speed in the region. The proposal suggests demarcating the Brookville area with low profile curbs, sidewalks and a Brookville sign. It is hoped this would help drivers identify that they are entering a community area and need to slow down.


Suggestions were made to set a very low speed limit in the immediate area of the school, and to install flashing lights to designate the

school area. Many concerns were raised regarding the buses turning onto Guelph Line, particularly during busier traffic times.

The meeting closed with Mr. Horton encouraging the public to fill out the public comment sheet that was available and returning it to the Region within the next week.

The next phase in the Class Environmental Assessment process will be to document the findings in an Environmental Study Report. It will be presented to the Region for approval, with 30 days provided for public input and comment. Once the report is approved, the plans will be finalized, with construction planned for 2004.


