programs. It's also a shame that I had to turn away 17 kids this year because we didn't have the equipment for them." While Ms. Anderson agrees that the Riders Ready program is an admirable project, she emphasized that CSAC must look at the benefit to the community of any application. "The application stated that the bikes needed to be custom designed per child and the Committee looks at how they will be re-used over time," explains Joy. "I would suggest that if there are individuals in Milton that would like to take part in this program, that they submit an individual application to get some funding towards the purchase of their bike."

It's not unusual for the Committee to recommend to Council any areas in which they feel tax dollars, not the Community Fund, should support the initiative on an ongoing basis as in the cases of both Track 2000, which has an agreement with the Town to use Park, and the Drumquin Campbellville Business Area

Although Association. the Committee declined CABA's application, CABA's request will now become part of the Gateway Signage Project that includes new signage, updates and maintenance as needed. As well, the Town website is being upgraded and more information about CABA/ Campbellville will be included on the Town site.

The next deadline for applications for the Community Fund is October 7, and Ms. Anderson encourages anyone who has questions about past declined applications and wishes to re-submit an application to contact her at 905-702-3143. "I try to be as honest as possible," says Ms. Anderson. "I encourage all applicants review in detail the purpose and eligibility information to make sure their proposal is within the guidelines. My role is to help applicants to put forward the best picture of what they want to do and why. CSAC wants to make an investment, but they also want it to be the right investment for the community."

The Kean family will finally be able to rest in peace with an agreement being reached by Tuscany Ridge Developments and the Town of Milton Council on Monday August 26. Tuscany Ridge had maintained all along it's willingness to upgrade the cemetery boundaries, restore the cemetery and provide community access to the pioneer location, but not until it had the full assurance of the Council's approval of it's application to zone the property for development of three lots around the cemetery. Town staff and Tuscany Ridge were able to reach an agreement that would see a condition attached to the zoning change that required Tuscany Ridge to provide securities equal to the restoration work. This agreement ensures that the work will be completed while allowing work to begin concurrently with the development of the second phase of the subdivision

Access to the cemetery will not be from Second Line as the original application suggested, but rather as a four metre permanent gravelled pathway from Kean Hill Drive. This will allow for pedestrian access only, and will not call for extensive tree removal. Some form of steps will be implemented near the top of the path to allow for easy travelling on the top of the ridge.






