ticipants the Halton Agricultural Advisory
Committee (HAAC) hosted it's 2002
Halton Farm Tour on Thursday
September 12. This year's theme
(Changing Times, Current Issues)
focused on the adaptations that
Halton's farming community are currently facing.

The first concern of many of Milton's rural residents is the industrialization of agricultural land - more specifically the proposed CN Intermodal facility. The tour's first stop was the Marshall farm which is situated directly across from the proposed site on Lower Base Line.

Robert and Joan Marshall are the fourth generation to operate this 100-acre farm which was originally

granted to Robert's great grandfather (John Marshall) in 1853. John Marshall purchased an additional 100 acres of land on the north side of Lower Base Line in 1873. For many years this farm was a 200-acre operation for approximately 60 head of Holstein cattle. In the '70's the second parcel of land was sold and by the late '90's the farm had ceased it's dairy operation but still continues to carry on a hay and cash crop business.

That second parcel of land is now owned by CN and is rented out for farming purposes. It was September of 2000 when Mr. Marshall received his first real estate offer for his remaining land. It is believed that CN was trying to purchase all of the perimeter sites. To

date approximately 1000 acres of land has been purchased by a variety of numbered companies and in February of 2001 CN announced their proposal to build a large intermodal yard that would be approximately 400 acres in size.

As Mr. Marshall says, "Taking all this land out of agriculture is not a good thing . . . this is one of the heartier areas in the county. Some of the best lands in Halton have been built up but this is still a good pocket of farm land." The construction and operation of this intermodal site will inevitably bring with it many negative factors. The noise and air pollution will effect all local residents not to mention sensitive crops such as soybean. The high intensity lighting systems may cause confusion to cattle

because the nights will not be a dark as they are now. The odours of the locomotives and the diesel trucks could cause problems for the residents that are down wind from the site (an increase in asthma and other breathing problems). The increased traffic (up to 800 trucks per day) on these rural roadways will not only cause damage to the roads but decrease safety.

Mr. Marshall also believes that the CN Intermodal yard will bring other future industrialized development to an area in the region that is not currently zoned for such development. To date, CN has not made application for the proposed use of this site and Mr. Marshall stated that we (Halton residents) are currently at the mercy of the CTA and waiting for word about the future.

Brandalea Farm, in Halton Hills, was the second stop on this year's tour. Harry and Judy Brander purchased this farm in 1975. They currently own 195 acres and rent an additional 300 acres. The Branders currently operate a beef feed lot. The cattle are purchased at about 900 pounds and resold approximately 140 to 160 days later when their weight has increased to 1400-1500 pounds. About 400 head of cattle pass through the operation each year with approximately 240 on the property at any one time. Mr. Brander's farm also consists of corn and hay (grown for feed) and wheat and soybean (cash crops for proper crop rotation).


