rural Ontario, especially as global climate change is leading to increased drought, is extremely important. Increased housing development in the Moffat area is already contributing to the depletion of groundwater in the Bronte Creek watershed, and Nassaw Springs application cannot be considered in isolation of this.

As a rural community, Moffat residents use the roads for walking, cycling and horseback riding. Encouraging heavy truck traffic through a small village six days a week will have a significant detrimental effect on Moffat residents' enjoyment of their community. Noise and air pollution will be

increased, and the roads will be less safe for humans and wildlife.

It is not, in our considered opinion, in the best interest of the Bronte Creek watershed or the residents of Moffat to support water taking from the Nassaw Springs property.

Ratepayers of the Town of Milton are reminded that the first instalment of the 2003 interim billing is due on Feb. 28, 2003.

If you require information about taxes, please contact the Corporate Services (Tax) Department at (905) 878-7252 ext. 2193, 8:30a.m. to 4:30 p.m. Monday to Friday.

Tax payments must be received in the Corporate Services Office on or before the due date to avoid penalty. A late payment charge of 1 1/4 % will be charged on the first day of default and on the first day of each calendar month in which the default continues.

It is the responsibility of the ratepayer to ensure that the taxes are paid by the due date, even in the event that the bill is not received as mailed.
