## Nutrient Management Act revised

armers have raised a stink A about the proposed manure management regulations and the Eves government has responded to their concerns. Changes to phase two of the Nutrient Management Act, originally due to be initiated in April 2003, will see revisions that

address enforcement dates and allow for future cost-sharing programs for compliance.

Between November 2002 and February 2003, consultations have been held across the province between the government and farmers. The government is trying to

establish workable guidelines around nutrient management that will encourage farmers to do their part to protect our water supply, while ensuring that compliance won't drive them out of business.

Changes to phase two include simplifying proposed regulations

and applying them initially only to new and expanding large livestock farms. Existing large livestock farms will be covered by regulations in 2005, while other farms will not be covered until at least 2008, depending on recommendations from a provincial advisory committee and

the availability of cost-shared fund-

"Farmers have, for years, voluntarily used environmentally responsible practices, and the government will continue to encourage them to do so," said Agriculture Minister Helen Johns.

#### Rural Waste Collection: It's Your Choice


Do you prefer the flexibility of arranging for your own household waste collection, or would you prefer to receive waste collection from Halton Region?

#### Be Part of Halton Region's Official Plan Review

The statutory five-year review of the current Regional Official Plan (1995) commenced in the summer of 2002. As directed by Council, Regional staff undertook an extensive consultation program on the Directions Report and the thirteen technical background papers from mid-September 2002 to early February 2003, which included numerous open houses, workshops, and meetings with individual interest groups. Based on the comments/submissions received, staff has prepared a "Response to Comments on Directions Report (March 2003)", and a "Submissions Document (march 2003)". Through Staff Report PPW43-03 in the agenda of the Region's Planning and Public Works Committee meeting on March 19, 2003, these documents are being released to the public and agencies for comment and a statutory public meeting will be held to receive public comments on the Official Plan Review.
