"We think we're going to drop some of the levels, but we don't .think we're going to make anyone's well run dry," stated Mr. Belanger. "If we break it, we'll fix it at no cost to the well owner. We are allowed

an interference effect, but not a sig-Residents effect." nificant expressed concern at what they felt was vague terminology when it was explained that the City of Guelph would not be held responsible for wells running dry due to broken pumps or drought conditions. When a local resident sarcastically

asked, "When the water stops, is that your definition of significant?" the answer from City of Guelph staff was, "Yes, that's correct."

In all, 44 questions and concerns were logged by Region of Halton staff in attendance at the Brookville meeting. These will be forwarded on to the City of Guelph to be answered.

As well, Regional staff will review Guelph's technical reports, well records and a report prepared by Puslinch's hydrogeologist. Although the City of Guelph is hoping to have the proposal approved in time to have the new wells in place before increased

demand in the summer of 2004, Halton Region staff intends to take all the time necessary to prepare a thorough report. Staff may have recommendations ready for Regional Council in December, but if it is more realistic the Arkell Springs project will come before council in February.
