

#### Key Plan



The Town of Milton has initiated a Class Environmental Assessment to consider the relocation of the Town's Engineering Services - Operations Facility currently located at 101 Nipissing Road.

The study will define the current Operations Facility deficiencies and consider, evaluate and detail alternative solutions and design concepts. In addition, consideration will be given to projected growth, future service demand requirements, current Operations status and the possible advantages of a multi-purpose site for a Fire Dept. training center, transit depot, animal control and future Milton Hydro facility

The study will be conducted in compliance with Schedule 'C' of the Municipal Engineers Association "Municipal Class Environmental

Assessment", (June 2000).

A key component of the study will be consultation with interested stakeholders (public and regulatory agencies). A Public Information Centre (PIC) will be held on October 19, 2004 at Hugh Foster Hall (43 Brown Street) from 4:00 p.m. to 6:00 p.m. Interested parties will be given an opportunity to review and discuss issues related to the project, including existing conditions, an assessment of alternatives, selection of the preferred alternative and environmental considerations.

#### NOTICE OF BY-LAW PASSAGE

## **Animal Control By-law**

On September 27, 2004 Town Council passed a new animal control by-law for the Town of Milton. This by-law requires that:

- All dogs in Milton must be licensed
- · Dogs must be leashed when they are in a public place or on private property without the consent of the property owner. The leash shall not exceed 2.1 metres in length
- If you have a prohibited animal in your possession, you must register it with the Clerk's Office by January 31, 2005
- Pigeons may only be kept in the rural area
- No more than 2 dogs in the urban area and 3 in the rural area
- No more than 3 cats in the urban area and 5 in the rural area
- No animal may be at large in any public place or on private property without the consent of the property owner
- Poop and scoop applies to all animals
- Animals must be kept in a humane manner
- · Interim muzzle orders may be issued against biting dogs
