"We thought it would contribute to the look of downtown Milton as well," Ron said.

Fiona jumped in and commented, "It's all a part of keeping this area active and to continue to grow. The store looks more open and inviting and that is important."

Challenging mind teasers and puzzles dot the educational toyshop. It gives both parent and child a chance to discover what suits them.

"We prefer to be downtown. It's just the kind of business that needs to be downtown," Ron said.
