The long and winding road

"As always, sound fiscal policies and a strong local economy are to thank for these top ratings," said Regional Chairman Joyce Savoline. "The reaffirmation of our AAA credit rating from these agencies helps to position us to successfully manage future challenges, while ensuring the health and safety of Halton residents. The report from Standard & Poor's, in particular, clearly shows Halton Region as a leading Canadian municipality in terms of the way we effectively manage our resources, and reflects the stability and strong financial management of our local municipalities."

According to Moody's Investor Service, Halton Region recorded positive results despite pressures on both its operating and capital budgets, which include increases to the police services budget, the opening of two new long-

trategically located within Central Ontario, the Greater Golden Horseshoe is predicted to grow by almost four million people by the year 2031. Approximately 75 percent of this growth is projected to occur between the Greater Toronto Area (GTA) and Hamilton, resulting in greater levels of local and interregional transit demands.

In the wake of the publicly decried Mid Penninsula Highway proposal, the Ontario Ministry of Transportation (MTO) has embarked on a new, expanded set of studies for a Niagara to GTA Corridor.

First on the MTO agenda though, is the development of the Terms of Reference (ToR) for the study. "People wanted a full Environmental Assessment that would look at other forms of transportation," explained Will MacKenzie, MTO Information Officer at a recent Public Information Centre (PIC) held by the MTO in Milton. "The Terms of Reference will describe how we do the Environmental Assessment. It lays out the criteria to ensure that everything is laid out properly."

Some attendees at the PIC were quick to express their disappointment at the lack of any details on proposed transportation options within the study. "What I'm seeing here is a lot of smoke and mirrors with no definite route," complained Campbellville resident Kevin Brackley. Robert Beyette, also of Campbellville was quick to concur, adding, "We haven't qualified or quantified the problem, yet we're trying to impose solutions. How can you propose solutions if we haven't agreed on the problem?"

MTO staff at the PIC however, argued that the purpose of the PIC was to provide a forum into the draft Terms of Reference and nothing more at this point in time, as the MTO is not yet beyond that stage of the process. "You have to look ahead as to what will be required to meet the



needs of the citizens so they have adequate transportation," explained Will Mackenzie. "There is not going to be one simple answer. Even now, we are looking at a concept or a series of concepts. What they will look like, we have no idea until we complete the process and we can't even begin the process without the approved Terms of Reference."

Milton Councillor Wendy Schau was particularly pleased with the "we're not here to push for a highway" approach expressed by Mr. MacKenzie and his colleagues. "I would like the highway to be the last option they consider," said Councillor Schau. "We need to really look at the use of rail and other forms of transit before we build a highway."
