
"Achieving a AAA credit rating allows Halton Region to continue to invest in our



#### Tax Planning 101: 3 Basic Strategies for Reducing Your Taxes

This time of year, people write me asking what they can do to reduce their tax burden. While it may be too late to alter your 2004 tax year, now is the time to start arranging your finances for 2005.

1. The RRSP is the single best tax shelter available, yet it is surprisingly underutilized. Most do not fully understand how good a deal the RRSP is, and that programs such as the Home Buyers Plan and the Lifelong Learning Plan offer tremendous flexibility to those who wish to access their funds to buy a house or return to school. If you have money and contribution room, RRSPs should be your first

stop to tax savings.

2. Labour-sponsored investment funds (LSIFs) offer generous tax credits to encourage Canadians to provide venture capital to smaller firms. A maximum annual investment of \$5,000 will receive a 15% credit from the federal government, and Ontario residents receive an additional 5% credit - total tax credit of \$1,750 - for

research oriented investment

funds (ROIF).

3. In Canada, proceeds from the sale of a principal residence are exempt from capital gain taxation effectively making your home a significant tax-free savings vehicle. Other nonregistered investments will generate taxable income but the appreciation on a home is completely sheltered. Once RRSPs have been

maximized and debts eliminated, then it may be time to determine if more complicated tax savings strategies including universal life insurance policies, investment tax shelters and limited partnerships are desirable. The solution to most Canadians' tax problems, however, is neither exciting nor drastic. There's no magic bullet to reduce taxes - it's just a matter of hard work and disciplined saving.



## Help Keep Halton Beautiful **Blue Box Recycling Tips**

You can help reduce litter with some simple steps to prevent your recyclables from taking flight on windy days. Please ensure your blue box materials are placed curbside in a secure manner.

- · On windy days, place your blue boxes out for collection on the morning of collection day by 7:00 a.m. instead of the night before.
- If possible, stack your blue boxes on top of one another to prevent papers from blowing away.
- Fill boxboard boxes with other boxboard material.
- Place heavier items on top of lighter items.
- Flatten and tie large cardboard boxes and place securely underneath or between your recycling boxes.



# Irban Yard Waste **Collection Begins**

From April 6 to December 7, Yard Waste materials will be collected every other week on the same day as recycling. Use open, reusable, rigid containers or paper yard waste bags. Please do not use cardboard boxes, blue boxes or plastic bags for collection. Brush must be tied in bundles no larger than 1.2 m (4 ft) long by 0.6 m (2 ft) wide, with branches a maximum of 7.5 cm (3 inches) in diameter. Grass clippings will not be collected. Please grasscycle by leaving grass dippings on your lawn.

Bags, containers and bundles set out for collection must not be heavier than 23 kg (50 lbs).

Tip: Use open, rigid, reusable containers with a yard waste sticker placed on it and drill holes in the bottom of your garbage can for drainage. Use paper yard waste bags to handle the overflow during high volume times.

Yard waste labels are available free of charge from Halton Region.
