Turner organizing Town Hall meetings

arth Turner, PC federal candidate in Halton, has organized a series of public meetings to take place across the riding, in Milton, Oakville, Burlington and rural Nassagaweya. They're free, open to anyone to attend, and will give voters and residents here the first opportunity they have had since 1993 to speak up on national issues - from taxation, to health care, crime, immigration and interest rates.

"As the MP for the former riding of Halton-Peel, I found Town Hall meetings to be essential in staying in touch with people," Turner, the Conservative candi-

date in Halton, says. "I just don't know how the last two Liberal members of Parliament could have functioned effectively, representing voters, without giving them such a way to communicate. If elected, my commitment is that Town Halls will continue to be a hallmark of the way I operate as MP - giving Halton's message to Ottawa, instead of the other way around."

During his five years as an MP, Turner hosted more than 70 such meetings. Since then, he has been a well-known television broadcaster, the author of a string of best-selling books, syndicated

newspaper columnist, financial lecturer and entrepreneur. Turner is founder and CEO of a network television production company and a growing retail and restaurant operation in Caledon.

"As a Halton resident, a small business guy and another over-taxed Canadian, I know our lives are filled with everyday issues the national government can help us with," Turner says. "Outrageous gasoline prices are a good example, since Ottawa contributes to the problem by raising the cost of gas some 30% through excessive taxation.

"The growing cost of mortgage

money is another, since the recent Liberal-NDP budget raised spending by almost \$5 billion. Economists warned this would result in higher interest charges, and that's exactly what's happening. Instead of being denied a chance to have their voices heard on these issues, constituents need to be involved. With me as MP, that will hap-




