**October 6**

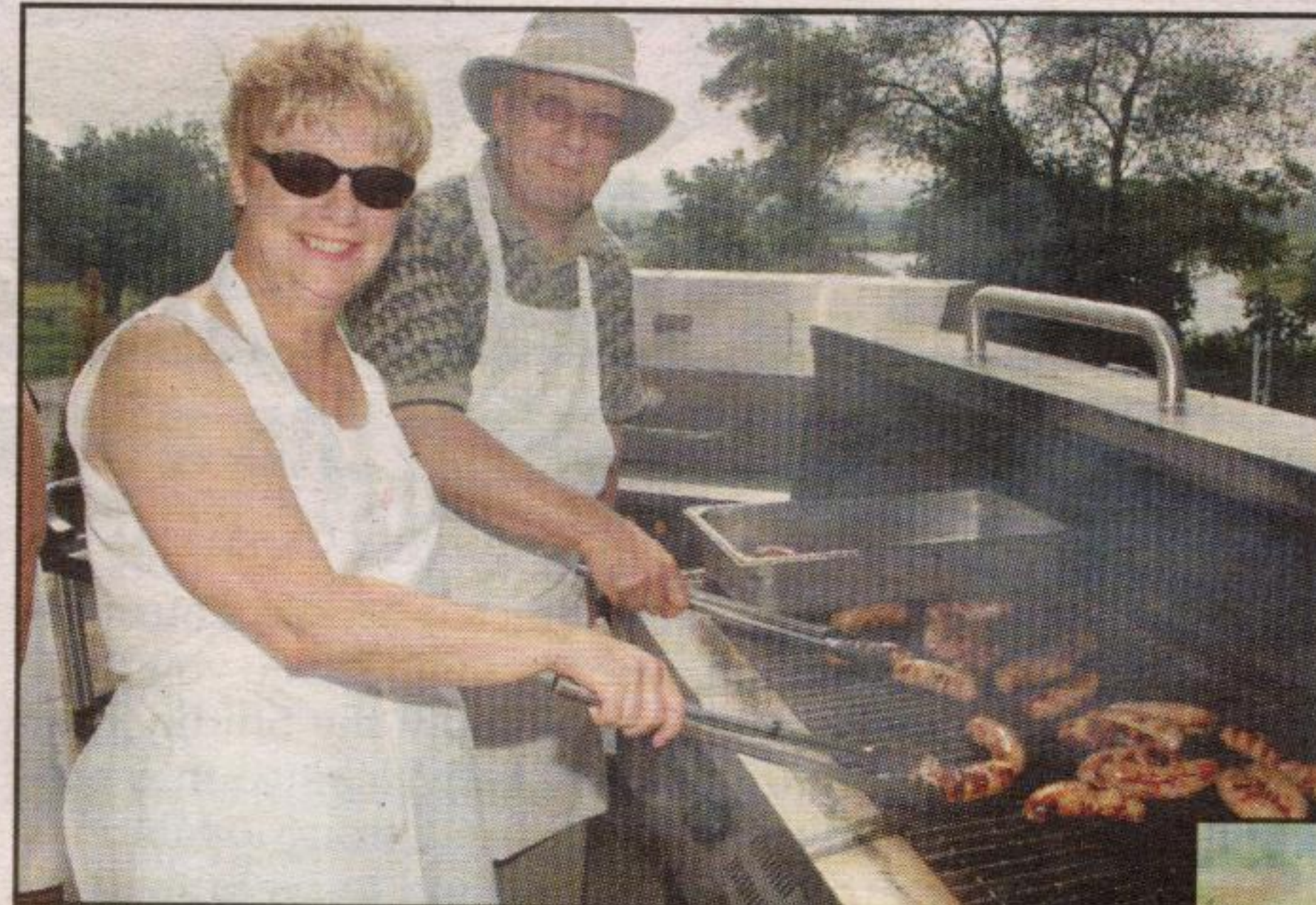

### NOTICE OF ROAD ALLOWANCE CLOSURE

#### Trafalgar Road (Regional Road 3) at Lower Base Line, Town of Milton

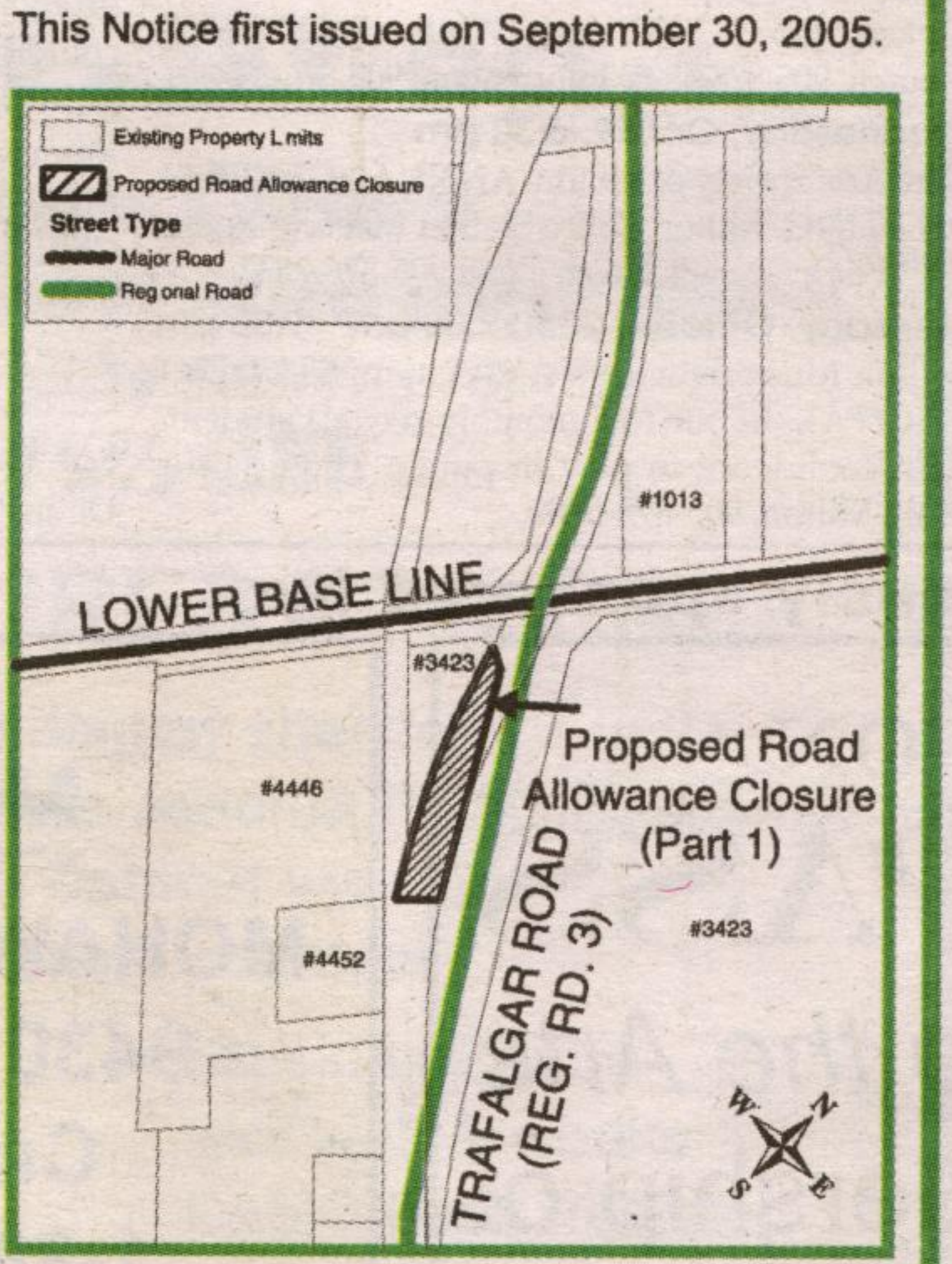
The Regional Municipality of Halton is recommending the approval of a by-law for the permanent closure of a road allowance adjacent to Trafalgar Road (Regional Road 3) in the Town of Milton. The property is located on the southwest quadrant of the intersection of Trafalgar Road (Regional Road 3) and Lower Base Line, more specifically referred to as follows:

**Part of Lot 12, Concession 2, north of Dundas Street (Trafalgar) Described as Part 1 on Plan 20R-16182 Town of Milton, Regional Municipality of Halton Part of PIN 24930-0098 (LT)**

Regional staff are recommending that the property in question be declared surplus, thereby requiring deletion from the Regional Road system. Pursuant to S. 34(1) of the Municipal Act and Halton Region Notice Provisions Policy, public notice must be given for a minimum of 2 consecutive weeks, not less than 14 days prior to the consideration of the By-law. Regional Council proposes at its Administration/Finance Committee meeting on Oct. 19, 2005 (1:30 pm) and Council meeting on Oct. 26, 2005 (9:30 am) to pass a By-law for the permanent closure of this unopened road allowance adjacent to Trafalgar Road (Regional Road 3) in the Town of Milton.

### ONTARIO REALTY CORPORATION PROPOSED SALE OF THE COUNTRY HERITAGE PARK PROPERTY CLASS ENVIRONMENTAL ASSESSMENT NOTICE OF PUBLIC OPEN HOUSE

Earth Tech Canada Inc., on behalf of the Ontario Realty Corporation (ORC), is conducting an Environmental Assessment (EA) for the proposed sale of the Country Heritage Park (CHP) property (formerly the Ontario Agricultural Museum) to the current operators of the site for its continued use.



Currently, the Ontario Ministry of Agriculture, Food and Rural Affairs (OMAFRA) leases the property to Country Heritage Experience Inc. (CHE), a not-for-profit, privately owned company. OMAFRA is considering selling the property to CHE for its continued use as a heritage park and agricultural museum. The property consists of 69 buildings of varying age and heritage value located on approximately 80 acres immediately south of Highway 401, adjacent to the Kelso Conservation Area, in Milton, Ontario.
