here's no money in the kitty, but trustees at Halton District School Board have voted to go forward with the building of at least two new schools in an effort to avert what staff are calling an accommodation crisis.

"It's very clear that Halton has a situation that has not been addressed," said Gerry Cullen, superintendent of facility services.

No longer willing to wait for the province to release details of the new funding formula, the board has decided to forge on ahead in dealing with the tremendous growth pressures.

With 3,500 students currently in portables and another 2,000 expected in enrollment next year, trustees voted to build two new schools by accessing \$9.1 million in education development charge reserves as well as a possible \$8 million in funds designated for a wide-area bandwidth upgrade.

"Just get them built. The consequences are just incredible for the students," said Bruce Jones, trustee, Ward 1 and 2 Oakville.

The two schools, one in Burlington and one in Milton are slated to be built for September 2006, but another two schools are needed - one in Oakville and another in Georgetown.

As one of the province's growth boards, accommodations have been problematic for

some time and although the Halton board is not the only growth board out of 72 provincially, it is one of the fastest growing.

Up until last winter, closing schools in order to create eligibility for new ones was one of the only strategies available to growing boards. In February of 2005, the Ministry of Education released its Good Places to Learn report which indicates this practice will no longer work.

It was never a popular practice with residents who were often not pleased to give up a school in one area so that one could be opened in another and it was a divisive practice that left trustees in a difficult position.

Unfortunately, the current situation is not much better.

"If we don't build we'll be lynched by the public, but if we do, we could be hung out to dry by the ministry," said Jones.

Despite the clear need, not all trustees were comfortable with the proposed plan.

Debbie Downs pointed out that the board was contemplating the use of \$9.1 million that they don't really have as approval to use this money must still come from the Ministry of Education. She also felt that using the \$8 million slated for technology upgrades was tantamount to raiding the classroom.

"This is so far removed from fiduciary responsibility that I just cannot fathom it," she said.



