
Purpose and Effect: The purpose of the proposed Official Plan Amendment is to permit the establishment of a new cemetery on lands known municipally as 12337 17 Side Road. The subject property is approximately 17ha in size and is located on the north side of 17 Side Road, west of Trafalgar Road (Regional Road 3). A related Local Official Plan Amendment (D09/Catholic Cemetery) and Zoning By-law Amendment (D14/Catholic Cemetery) have been submitted to the Town of Halton Hills.

Purpose Of the Amendment: The purpose of this amendment to the Official Plan for the Halton Planning Area, Regional Municipality of Halton, is to apply the appropriate Regional Official Plan designations to the Ninth Line Corridor that reflect the recommendations of the Final Report - Ninth Line Corridor Protection and Land Use Study (May 2005) as amended. The Final Report's recommendations focus on protecting the corridor's land base for the development of the 407 inter-regional transitway and its associated infrastructure, while identifying the most appropriate long-term uses for the balance of the lands in the corridor that are complementary to and supportive of the transit line. It also provides direction to the Town of Milton regarding the local detailed land uses that will be applied to the corridor through a separate process at a future date. The Ninth Line Corridor comprises approximately 395 ha. The amendment affects all lands between Hwy 401 on the north, and Hwy 407 on the west, and Ninth Line on the east and Hwy 403 on the south. The Corridor is more specifically described as including lands from Concession 9 NS, Part Lot 14 in the north to Concession 2 NDS PT Lot 6; PL Ex 185 Part 1 in the south.

Explanation: The public meeting is concerning Amendment No. 28 to the Halton Region Official Plan as outlined above. Persons having an interest in this matter, may present their comments to the Committee.

If a person or public body that files a notice of appeal of decision of the Regional Municipality of Halton in respect of the proposed Official Plan Amendment and does not make an oral submission at a public meeting or make written submission to the Regional Municipality of Halton before the proposed Official Plan Amendment is adopted, the Ontario Municipal Board may dismiss all or part of the appeal. Legislated notice has been provided to those neighbours affected by the proposal, as required under the Planning Act.
