

Government of Canada moves to restrict conditional sentencing

Rederal Justice Minister Irwin Cotler has introduced legislation in the House of Commons that would restrict the use of conditional sentences for serious and violent offences.

The reforms introduced in this legislation will prevent courts from using conditional sentence in cases of:

- serious personal injury offences as defined in the Criminal Code, such as all forms of sexual assault;
- terrorist activities;
- · organized crime-related offences; and
- any other offence where the individual case is so serious that the need to condemn the act - and not use a conditional sentence - takes precedence over any other sentencing objective.

The implementation of this legislation would mean that courts would be required to explain in writing any exceptional circumstances that lead them to believe it would be in the interests of justice to use a conditional sentence in such cases.

"This Bill is part of our set of initiatives to better protect Canadians and make our communities safe," declared M.P. Gary Carr. The new legislation extends child protection laws by removing conditional sentences as an option for offenders who sexually assault children - thus reflecting the serious harm caused by such offences.

These reforms will strengthen public confidence in the conditional sentence and in the administration of justice. At the same time they are consistent with Canada's balanced approach to sentencing, with harsh penalties for high-risk offenders and the use of community-based approaches for those who commit less serious crimes.

"I am very happy with the introduction of this legislation. Together, we can create a safer Halton, and Canada", said M.P. Gary Carr.
