Raising awareness of life-threatening allergies

Anaphylaxis is a condition that is receiving more and more attention each day. The life threatening allergic reaction to certain foods, such as nuts, dairy products, shellfish, soy and more, as well as sulphides, latex and insect stings, was the subject of a Bill that was unanimously approved by the Ontario Legislature. In January of 2006, Sabrina's law, named in memory of Sabrina Shannon, a Pembroke student who died from anaphylaxis in 2003, requires all publicly funded schools to educate students and staff about anaphylaxis, and to have response measures in place.

The legislation is a huge relief for mothers like Tracy Moroney, who helped to pioneer awareness of the life threatening allergy within the Halton District School Board over a decade ago. Her son Ryan, then aged four almost died after eating a cookie at pre-school. The cookie contained no nut products but had been baked on a cookie sheet that had been used for peanut butter cookies three days before, despite the fact that the cookie sheet had been washed afterwards. "I thought we were being safe but that blew me away," says Mrs. Moroney of just how easily and inadvertently anaphylaxis can be triggered. She was instrumental in working with the Halton District School Board on establishing protocols to ensure student safety and is quick to praise the upcoming implementation of Sabrina's Law, especially in secondary schools.

"All these years we've been raising awareness at the elementary level, but there was nothing in the high schools," she says. "The issue didn't exist at the high school level. These kids need their peers to be aware more than ever. You just don't know when it is going to happen. They need to know that an epi-pen can save a life and

should be carried at all times."

A support group is available to those struggling with the issue of anaphylaxis. The next meeting will be at the Halton Regional Police Headquarters at 440 Locust Street in Burlington. It will start at 7:30 p.m. in the "Skerret Room" on Tuesday November 29. 
