



had on his Ford Mustang. As my van was stopped in the middle of the road not one passerby stopped to assist me or stop to say they had witnessed the accident. I called 911 on my cell phone for police and ambulance assistance as the ignorant driver

I hit was injured. I remained at the scene unassisted by anyone until my husband and

police arrived.

As the police officers began their investigation I was made aware that this driver was carrying no insurance on his vehicle. The driver at least made a statement that the accident was his fault to me. But I, as the victim, am still responsible to pay a premium of \$300 because he held no insurance. Is that fair? Where is the justice in that! The lost time from my job due to injuries is my insurance's responsibility. This has a tremendous impact on a person even

though it wasn't my fault. There are a lot of what if's


..... going through my mind like if he had a passenger in his car would there have been a fatality? What if my children had been in my vehicle with me? Would they have been injured? And what it makes me feel like when I drive around that bend every day on my way home from work. This memory will always be there.

This driver has no consideration for other motorists only on how he can save himself money. There must be a way that these type of people can legally be stopped and made responsible before they cause an accident and put other innocent people through unnecessary trauma. As a victim this is a totally new experience for me, one I will not forget thanks to this individual.

In closing I would like to state that people that feel they are beating the system by driving with no insurance aren't saving money but are showing how ignorant and selfish they are towards fellow motorists that are honest and responsible on the roads. I feel they should personally be held responsible for all costs incurred by the victim instead of the victim's insurance company.

The fine these motorists receive is an automatic \$5,000 so in the long run what money are you really saving? I hope you can live with that on your conscience.
