"There's some real anticipation of a larger food store in Acton...and that's in the works, and there's going to be \$7 million in upgrades to the sewage and water treatment plant ... it's really great that we're getting things moving," Serjeantson said, adding one downside to the campaign has been the theft of 'piles" of her election signs.

Kathy Gastle

Current Ward 2 local councillor Kathy Gastle predicts she'll win in a landslide. based, in part, on a "tidal wave for change."

"What I'm hearing - and

loud and clear at the door in Acton - is that people are supporting me," Gastle said recently.

"There is a tidal wave for change. It's unbelievable, I had no idea. I heard from a lot of people at the (Acton) fall fair, but door-to-door it is phenomenal," Gastle said, adding people have "a lot of issues that they felt that she (Serjeantson) hasn't dealt with properly," including the proposed sale of land at McKenzie-Smith Bennett.

Gastle was first elected as the Ward 2 local councillor in 1991 and appointed as Regional councillor five years ago when incumbent councillor Bill Robson died suddenly. Re-elected in 1994. Gastle handily won the local seat in the last election, taking over half of the votes

Rob Heaton

Heaton is a Glen Williams native who was first elected to Town council as the local Ward 2 councillor twelve years ago. He held that seat until the 1997 election when he lost the newly combined Wards 1 and 2 regional seat to Councillor Rick Bonnette.

Heaton, who was often the lone dissenting voice on past councils, says he is a "alternative choice vs. more of the same" and "a way of maintaining solidarity among direct-action groups," and is running a low-key campaign.

Heaton, who voted against Acton's Churchill Road fire station and was kicked off the Acton arena steering committee by the mayor for being disruptive, said when he goes to the door in Acton people say, "Well, we're voting for you. What are you doing here? Keep going."

The mayor's salary is \$41,788 plus \$19,626 for sitting on Halton Council for a total of \$61,414.


