

Bill would punish Dads if Ontario passes it

Dear Editor

I have written letters on several occasions regarding the state of our families, the increase in the divorce rate, and the impact on children that are raised in fatherless homes.

Last May, the National Post ran several articles on divorced fathers alleging that the Divorce Act has resulted in "punishing dad." My experience and research leads me to believe that the act is set up to "kill" dad or someone else.

The act is now tipped in favour of the person who has custody of the children, mostly women, and the Federal Financial Guidelines are unfair to the person having access or visitation rights, mostly men. In the name of "what's best for the children," there are good fathers committing suicide as they have few means to support themselves after paying alimony and child support.

Now the Ontario government wants to make the situation worse for these men by passing Bill 117. It has already

gone through second reading and according to the group FACT (Fathers Are Capable Too), "The Bill will codify the current situation and perpetuate female victimization. It is in contravention of the Charter of Rights and Freedoms and will create a huge potential liability costing the province and taxpayers potentially billions of dollars for every man falsely accused of abuse and without due process of

The bill allows for an "emergency intervention order," to strip an individual of their possessions (houses, children, bank account, car, and properties) as soon as a suspicion is uttered that the person has been abusive. It is intended to be gender neutral, but past divorce situations reveal that most men are "less equal." The legislation may be used against anyone who is, or was in a relationship of any kind, from a spouse to a former spouse to even a person who had a former dating relationship. Once the process is started, it cannot be stopped, not even

by the original complainant.

The bill is known as, The Domestic Violence Protection Act. It is being considered by the Standing Committee on Justice and Social Policy. The bill is structured to insure that the party accused, usually men, will not get any possessions back even if they are acquitted. The bill overrides any family law act. According to FACT, even yelling may result in the seizure of children, property, etc. from the accused. How many times in the past have false allegations been used in civil proceedings to prevent and often times eliminate a father from the child's life? According to a spokesman from the group, Equal Parents of Canada, the Ottawa Carleton Children's Aid Society found that 600 allegations of child abuse in 1998 were false.

Anyone wishing to oppose or comment on this bill should do so before the House reconvenes in March. Contact your provincial member of parliament for details.

Foot clinic costs doubled since VON took it over

I am writing in regard to the Foot Clinic held in Acton.

I've been using the service for nearly ten years. At that time, two nice ladies would come every six weeks and hold the clinics. They were very efficient, likable and considerate of our needs. The price then was ten dollars, which slowly rose to thirteen dollars a time. If needed, we were picked up at our home and returned at no cost.

For some reason unknown to me, about six months ago, these two ladies were replaced by two Victorian Order of Nurses. The prices immediately rose to twenty dollars. They decided to come every month, so there would be less confusion, I never thought we were confused before!

The first visit with the VON, I was asked a brief history of my illnesses. That was OK, but I objected to being asked questions about my age, health condition, etc. within sight and hearing of half a dozen other people who were waiting their turn. I also objected to having misshapen feet bared in front of them while the VON filed and cut my nails.

The first two ladies had portable screens that gave at least some privacy, and only two people would be in the room at a time.

Since the VON took over, I have seen at least five people get up and leave because although they had a definite time of appointment, the wait was so long that they could not stay and wait their turn.

Now I understand, free rides are no longer available. Rides are booked through the Red Cross at a cost of five dollars.

So, to get your feet taken care of, it now costs twenty-

five dollars. That's more then twice as much as it was four years ago.

All I know is, my income certainly hasn't doubled in that length of time. It doesn't seem fair to people on a pension, that we are paying twice as much for poor service. It sure is not "worth the drive to Acton."

Please don't sign my name. Miserable as the service is, I have no alternative but to use it.

Multiple roof lines, feature windows and stone accents enhance the design of this three-bedroom basement-entry plan.

Inside the covered entry, space is used judiciously to provide the optimum room where most needed. Just off the compact foyer is a generous-sized den with cupboard, ideal for office or guest bedroom. A three-piece bathroom with standing shower is placed immediately behind the den/bedroom and a coat cupboard completes the finished are on this level.

A door next to the bathroom opens to the unfinished part of the basement, with roughed in plumbing for a wet bar and bathroom. A rear door opens to a covered patio.


