## Plentiful water supply found for-Rockwood

They got water!

After months of searching and drilling two unsuccessful test wells, a plentiful new water supply has been found for the village of Rockwood.

Public Works foreman Greg Pierce told Guelph/ Eramosa councillors Wednesday that a new test well drilled earlier this month within the village boundaries has been found to have the water volume, which the community needs as its backup supply.

Pierce said the search for a new well began with a train derailment in 2000 when a diesel fuel spill threatened the village's existing water supply. Had contamination oc-

curred the community would require 42 tanker loads of water daily to supply its needs. Although the problem was avoided, the accident highlighted the danger of having only one source of water for the village and prompted the hunt for a new well.

Pierce said the well still has to be tested for water quality and meet assorted other Ministry of Environment (MOE) standards before it can be approved for use. A system will need to be designed for delivering the water to the community in case of any emergency and various permits will be needed from the MOE before the well can be brought into service.

He estimated that process will take a minimum of seven months to complete.

## Tax hike to homeowners

Preliminary facts and figures for the Guelph/Eramosa (G/E) budget show homeowners facing a two per cent increase in their 2002 tax bill.

As municipal treasurer Laura Smith put it, that's an \$18 hike on a home with a \$250,000 assessment.

Before anyone heaves any sighs of relief, however, she points out that's only the municipality's share of the bill and that's only on a house. Other assessment classes, such as commercial and farms, are set by Wellington County council as a ratio to residential rates. The County has not set those ratios yet and she has received no indication on the timing for that.

She also reminded council and the eight observers who turned up for the initial budget presentation, that the municipality only controls a small share of the tax levy. Last year the bill was divided approximately 44 per cent for the County, 31 per cent for education and 25 per cent for the municipality.

Adsett said the latest version of the County budget showed a 2.6 per cent increase over last year's figure. That would provide an increase of more than \$100 on a house assessed at \$175,000.

One comfort for taxpayers, Smith said, is the fact there won't be any reassessment this year. The next one comes in 2003 and will bring house values to the 2001

Reassessment played a big part in last year's huge increases because taxes are based on assessment and assessment is now based on current property values. Last year's reassessment moved property values from 1996 figures to 2000 values and house prices rose dramatically in that period.

Council received the recommendations from staff as a draft budget but held no discussion on the budget's contents. That will come later once taxpayers have had a chance to look at the figures, said Mayor Dave Adsett.


The timing of the presentation follows council's oftexpressed desire to set the municipal budget earlier in the year so taxpayers can adjust their personal budgets accordingly. However, since municipal tax bills must include County and education levies, delays by those bodies often seriously delay passage of the local budget.

The draft contained no unexpected items and continued work set out in the roads maintenance program and the parks and recreation master

Parks and recreation director Glen Smith suggested delaying the capital cost on the Marden Community Centre

# Hindley's decision to resign catches councillors by surprise

Councillor David Hindley's decision to resign caught his fellow members of Guelph/Eramosa council by Adsett said. some surprise, but not without understanding.

No one was aware of his changed viewpoint when they saw him at Wednesday's budget meeting although the announcement was made in a letter to the mayor faxed to the municipal office the following Thursday morning.

"The (Guelph) Mercury

hung him this morning (in an editorial calling for his resignation.)," Mayor David (Gibson-Smye) makes great copy for the Mercury, and the Tanner too. I think all the publicity council and the township was getting just got to him and he said he didn't need it."

Coun. Les Foote said he was "sorry to see it turn out this way. We'll miss him. He tried to do a good job."

"I supported his right to decide to stay so I guess I have to support his right to go," said Coun. Doug Breen. "But I told him if he was resigning for my sake he didn't need to bother. It's unfortunate. Notwithstanding his personal life, he was a really good councillor. He had excellent background and on a personal level, I'll miss him a lot." Coun. David McCrae also supported Hindley as a "decent man despite his personal problems" commended him for "probably (doing) the honourable thing here."

He said his only concern has always been whether Hindley had the right to retain his seat and the original legal opinion given to council seemed to support that because the Municipal Act is silent on such situations. "I understand now that the Elections Act was where he ran into trouble," McCrae said. "What annoys me is what we're paying a lawyer for. We aren't experts. That's why we went to a lawyer. This should have been researched more thoroughly in the first place."

Adsett and Breen both lay the resignation squarely at the door of former mayoralty candidate Teressa Gibson-Smye after her attack during Monday's council meeting.

Breen repeated his comments from Monday's council about the constant undermining of council activities which has taken place during this term.

"We're open to enough criticism in general; Dave may not have wanted to give them a legitimate reason to critisize," Breen said. "She got one of us and there's four more to go."

He said he received a number of calls after Monday's meeting and the general consensus was that Gibson-Smye was "just trying to get Adsett."

Adsett said council will probably follow its traditional pattern for filling vacancies by calling for applications rather than holding a by-election. Applicants would then be interviewed and the best candidate appointed to the seat.

Looking at his own career, Adsett said he was ready to walk away after one term as reeve. "All I ever wanted was to see a junior councillor come along ready to take over and carry on," he said. "But if you walk out people think you're a jerk. After this psychological warfare this term.... I don't have to put up with that."

people I represented," he said. "It was only a collective few who have done this." Referring to the vicious

nature of the attack on his personal and public life Hindley said "This is beyond my upbringing and I'm no

On the positive side, his council experience "got (his) mind working" and he enjoyed it.

Now he feels it's time to sit back and he won't be seeking the seat again at this time. "Although I may be seeing you in 2003," he said with a wink.
