Industrial subdivision

The public can comment on plans for a proposed industrial subdivision on the southern boundary of Halton Hills at a public meeting on May 21 at the Civic Centre.

M.R.S. Trust Company wants approval for a nine-lot subdivision, for dry industries only, on the northeast corner of Campbellville Road and Highway 25, and has filed a planning application and a zoning amendment request.

The Town's rural industrial designation for the 43.6-acre property is deferred, waiting for provincial approval and Halton's Official Plan permits dry industrial and associated uses, with private sewer and water services, on the site.

Fourth Line well

Improvements made to date on the Fourth Line wells in Acton were detailed for Halton councillors at a Regional meeting yesterday.

The Fourth Line wells were shut down in June when test results showed low levels of coliform in the raw untreated water.

Since water from the Fourth Line wells is needed from October to May when the capacity to take water from the Prospect Park well is cut in half, Halton hired a consultant to outline viable treatment technology, including an ultra-violet disinfection system and a post-disinfection chlorine contact tank.

The total cost of the work is \$305,000.

Post-Walkerton provincial regulations require Halton to study if the Fourth Line Wells are under the influence of ground water and if chemically assisted filtration is necessary.

Vandalism task force

A central registry system to list vandalism complaints and coordinate and track responses is one initiative that will be studied by the Town's new Vandalism Task Force committee.

The Task Force, including representatives from the police, Halton Hills Hydro, local Chamber of Commerce, Council, the Town and two residents, was suggested after Town staff said the current, but rarely used bylaw offering up to a \$1,000 cash reward to people who supply information leading to the conviction of anyone guilty of vandalism, lacks the administrative and financial support to maintain public interest.

A pre-Christmas report to Council said acts of vandalism - everything from mischievous, unpremeditated acts to wanton, malicious and deliberate destruction of property - are on the rise.

it's passed by Council, allows:

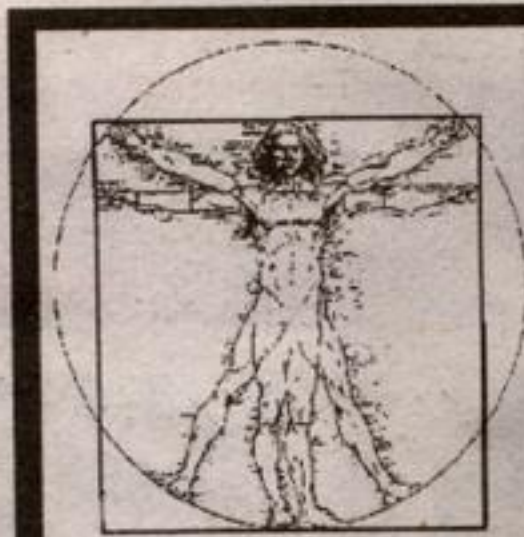
- Ø Seven foot high fences for rear and side yards with front yard fences and those on corner lots restricted to three feet
- Ø Allows wrought iron fences and those with an open construction to be 5.6 feet in the front yards on a corner lot
- Ø Allows chain link

fences but bans barbed wire, chicken wire or cable fences in residential neighbourhoods

Ø Removes hedges, shrubs and trees from the definition of fences

Ø Requires all fence owners to keep them in good repair with no broken, rusting or rotting parts that could cause a hazard

Ratepayers can comment on the bylaw prior to May 6.
