

Eves government moving to 'left'

The fact that the Eves government is moving to the left in order to catch more votes in the next provincial election has been confirmed by the Health Care initiative put forward by Ontario Health Minister Tony Clement.

He is proposing a more socialized system of health care where:

1. Physicians are going to "Choose" to switch to a salary basis. Quality physicians of course may choose to go and practice in the U.S. in-

2. Under the government's plan, more money is going to be spent. In the words of the minister, "incentives" need to be put in place for doctors to be

convinced of switching to the new approach (Family HealthNetwork). The minister forgets that "incentives" provided by government to government employees are not normally governed by the free market, but by the reasoning of some administrative bureaucrat. This has been shown to lead to waste of taxpayer's money.

3. The Liberal and NDP opposition agree with the direction of the government. Former NDP health minister Ruth Greer said: "I hope it works".

The Family Coalition Party of Ontario (Ontario Coalition) would use an approach, based on Medical Savings Accounts (MSA), which would not deprive Ontario of its best physicians and would introduce the real competition to provide universal and excellent health care service

In addition to MSA accounts, the Ontario Coalition would introduce a system of universal insurance where we, the users of the system, would be able to choose the best insurance for each person, above the standards set by government.

The system proposed by the Ontario Coalition would also, as a side effect, create incentives for young people to save, when they are young and healthy, and invest for their retirement (See www.OntarioCoalition.com

When I was a boy growing up in Acton, I really looked forward to the Beardmore Christmas party. We had the afternoon off school and more than half the kids in town were at the party, yelling and screaming for Santa to come. I got my first football there one year and wore it out from overuse, playing mainly in the cinder filled Beardmore parking lot.

When I aspired to go to university, I financed much of it by working five summers at Beardmore and when I needed to get some experience in an office setting related to my commerce course, Mr. Beatty gave me that opportunity. Everybody in the office and in the plant was great to me, although I never did find that bucket of blue steam!

My Dad was proud of the Beardmore leather products that he helped make. The house I grew up in was a Beardmore owned house that was sold to my parents on pretty reasonable terms. To be sure, it was not a perfect world – Acton was a company-controlled town, but it was a town where you knew everyone and where the son of a tannery worker could get advice and encouragement from the highest executive.

As stated in the article, we are very proud to carry on the tradition of this historical name. Wherever possible we utilize as many of the original Beardmore Tannery's historical photographs and print material


