



Approve public defibrillators

A proposal to provide defibrillators in public buildings to help save heart attack victims – a move championed by members of the Acton Seniors' Centre – has been approved by Halton Council.

Politicians instructed staff to beef up existing Cardiopulmonary Resuscitation (CPR) training and investigate, develop and/or facilitate a co-ordinated public defibrillation (PAD) program.

Although no statistics are available for Acton or Halton Hills, studies show Halton's 3.9 percentcardiac arrest survival rate is low, compared with 7.8 per cent and 8.5 per cent in Sarnia and Kingston, respectively.

As well, fewer Halton bystanders who witness a cardiac arrest step in to help compared with other Ontario rates. In a medical event where time is critical, getting a defibrillator to a victim within three minutes is a key part of a PAD program. Every minute that passes before the heart returns to a normal rhythm, the chance of survival drops by 10 per cent. Halton's report also said a total of almost 13 minutes elapses, on average, before a heart attack victim receives help after a 911 call:

When a visitor to a church dinner at the Acton Community Centre suffered a heart attack and died several years ago, the executive of the Centre's



board of directors asked Town staff to investigate putting defibrillators in public buildings.

That request was sent to the budget committee and deferred until the Regional report was complete.

Staff said the program would cost \$38,000 for the rest of the year, with one-time start-up costs of \$40,000 and annual operating costs of \$128,000.

Centre member, former Acton councillor Gerald Rennie said he was glad to see Halton was moving ahead with the defibrillator plan, but questioned why people had to be trained to use it when the Region's report quoteing a U.S. study said untrained Grade 6 students were only "modestly slower" in using defibrillators than emergency medical staff were.

Greg Sage, Halton's manager of training and quality assurance with Emergency Medical Services, said the Heart and Stroke Foundation of Ontario recommends "first responders" like security staff or arenamanagers, receive "training.

Defibrillators cost approximately \$5,000 and determining how many are needed in what locations is part of the investigation to be done by a steering committee that will be struck as part of Halton Council's approval of the CPR/PAD program.

Because a high percentage of cardiac arrests occur in the home, the study will also explore options to create a defibrillation program for in-home use of identified high-risk cardiac patients.


