

# Bruce Hood seeks Liberal nomination for new riding

Former NHL referee Bruce Hood has announced he is seeking the Federal Liberal nomination in the new riding of Wellington-Halton Hills. Hood made the announcement from his home in Erin, which is part of the new riding along with the Wellington County townships of Centre Wellington, Guelph/Eramosa and Puslinch; and the Town of Halton Hills in the Region of Halton.

For 21 years Hood was a referee with the National Hockey League. Following this career he entered the travel industry and owned and operated several successful travel agencies over a 15-year period. He was also vice-chair of the Travel Industry Council of Ontario and President of the Association of Canadian Travel Agencies.

In 2000, the federal government appointed Hood to a two-year term as Canada's first Air Travel Complaints Commissioner.

Throughout his professional life Hood has been on numerous boards and committees, and continues to support community organizations and service clubs.

"I am very excited at the opportunity to serve this new riding," said Hood. "I believe the experience and knowledge I have gained during my professional sports and business careers, and as a consumer representative in Ottawa, have prepared me to be a very good and effective voice for the people of Wellington-Halton Hills. 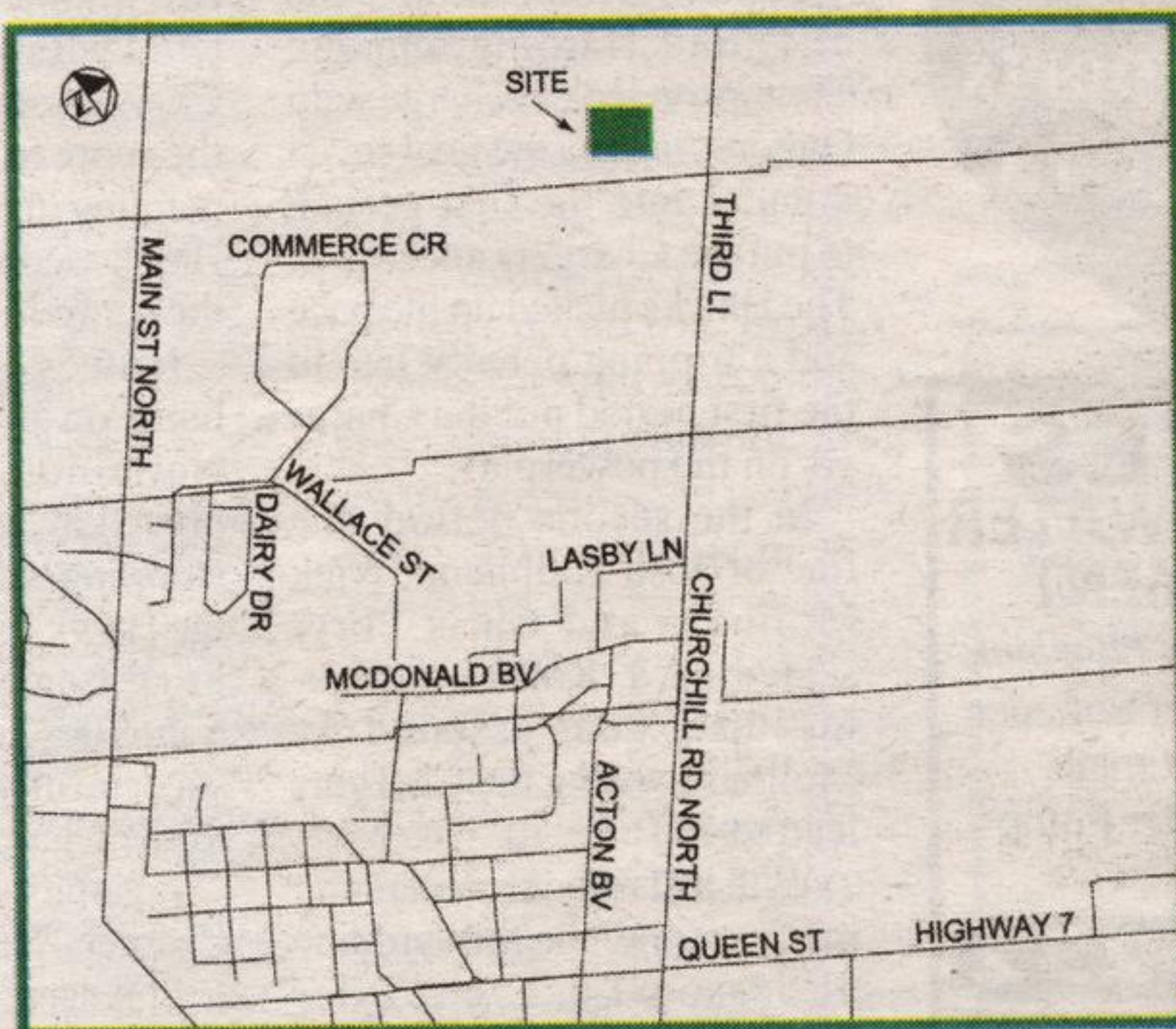
### DAVIDSON WELL PUMPING STATION UPGRADES CLASS ENVIRONMENTAL ASSESSMENT STUDY

The Regional Municipality of Halton has initiated a Class Environmental Assessment (EA) Study to upgrade the Davidson Well System to ensure that it meets and exceeds all Ministry of Environment requirements for well operation.

The Davidson Well Pumping Station is located at 14032 Churchill Road (Third Line north of Hwy. 7) in the Town of Halton Hills (Acton) and services the community in conjunction with the Fourth Line Well Pumping Station and the Prospect Park Water Treatment Plant.

The purpose of this Class EA is to assess the environmental impacts of upgrading the existing pumping station to include a standby generator by December 31, 2004, to fulfill the requirements of the Ministry of the Environment.

Alternative solutions have been evaluated to identify the most technically feasible, environmentally sound and practical solutions, subject to input being received from the public and relevant agencies.



This project is being planned under Schedule B of the "Municipal Class Environmental Assessment" dated June 2000.

Public input and comments are invited, for incorporation into the planning and design of this project and will be received until March 3, 2004.

Subject to comments received and the receipt of necessary approvals, the Regional Municipality of Halton intends to proceed with the planning, design and construction of the project, to be completed by fall 2004.

### Maple Avenue (Regional Road 11) Improvements Trafalgar Road (Regional Road 3) to Mountainview Road, Town of Halton Hills (Georgetown) Class Environmental Assessment Study, Schedule "B"

The study is being conducted in compliance with Schedule "B" of the Municipal Class Environmental Assessment Document.

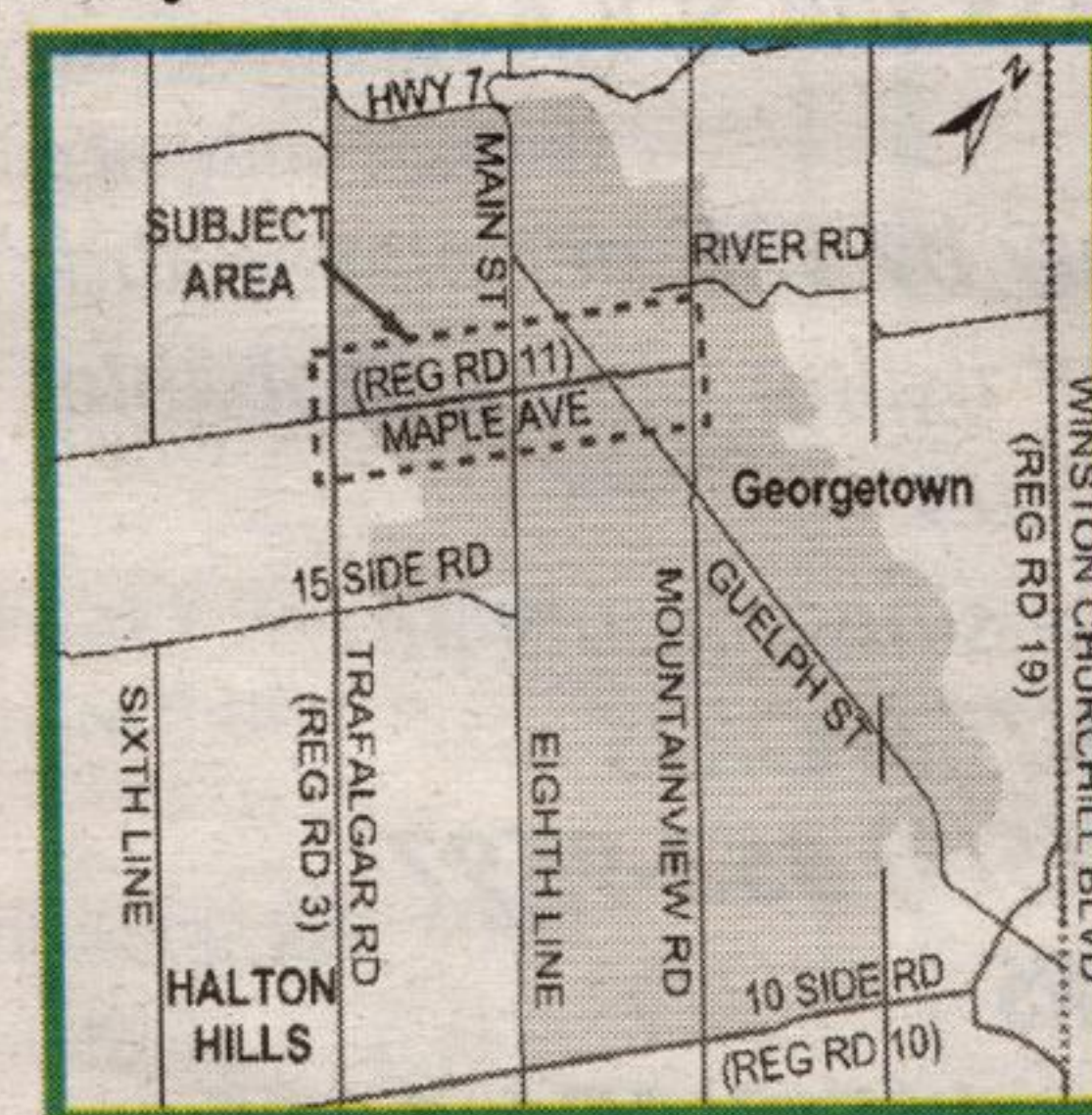
You are invited to attend our first public information centre scheduled for:
