### Help Keep Halton Beautiful **Blue Box Recycling Tips**

You can help reduce litter with some simple steps to prevent your recyclables from taking flight on windy days. Please ensure your blue box materials are placed curbside in a secure manner.



· On windy days, place your blue boxes out for collection on the morning of collection day by 7:00 a.m. instead of the night before.

· If possible, stack your blue boxes on top of one another to prevent papers from blowing away.

- Fill boxboard boxes with other boxboard material.
- Place heavier items on top of lighter items.
- Flatten and tie large cardboard boxes and place securely underneath or between your recycling boxes.

Halton Region will be holding a Public Information Meeting, pursuant to O. Reg. 244/02, s.12 (6) of the Municipal Act, 2001, to solicit feedback on the location of the portable Bulk Water Stations and to present the proposed fees and charges for bulk water dispensing and hydrant meter rental, including water consumption, as discussed at the Public Information Centre (PIC) held April 28, 2003.
