



What Sureties need to know

FAILURE TO OBEY A COURT ORDER

If the accuse person fails to appear in court or breaks any other term of the bail order, the accused person may be charged with another criminal offence.

If the person is found guilty if breaching the court order, the Crown may ask the court to make you pay the money you committed as a surety. A hearing will be scheduled. You and the accused person will be given at least 10 days notice of the date and place of the hearing.

The hearing is called estreatment. It will give you an opportunity to explain why you should not lose your money.

The judge may order that you pay all, part, or none of your money. Further legal action may be taken against you to collect the amount owing.

CASH DEPOSITS

In some cases, in addition to the surety's pledge to pay a specified amount of money, the accused will be required to deposit a sum of money to the court.

Where there has been a deposit of cash by the accused person, or by the surety on behalf of the accused and the case is over, that money is returned to the accused person and not to the surety.
