## Region supports green plan

Halton Regional Chairman Joyce Savoline extended her support to the McGuinty government's announcement to protect 1,286 acres of provincially owned lands to preserve greenspace within Halton Region. The announcement delivered at Bronte Creek Provincial Park by Natural Resources Minister David Ramsey is part of the Province's greenbelt initiative.

"This plan will ensure that the environmental legacy Halton has begun will endure for generations to come. We look forward to continuing the successful partnership with both the Province and our

local municipalities to protect Halton's natural environment," said Savoline.

Savoline noted that the Province's identification of 750 acres of government owned lands within the North Oakville area makes a significant contribution to the achievement of a Natural Heritage system that the Province, Region and Town have collaboratively been identifying through the Inter Agency Review.

"We are confident that continued collaboration amongst all levels of government will yield positive results for future environmental initiatives in Halton," Savoline said.

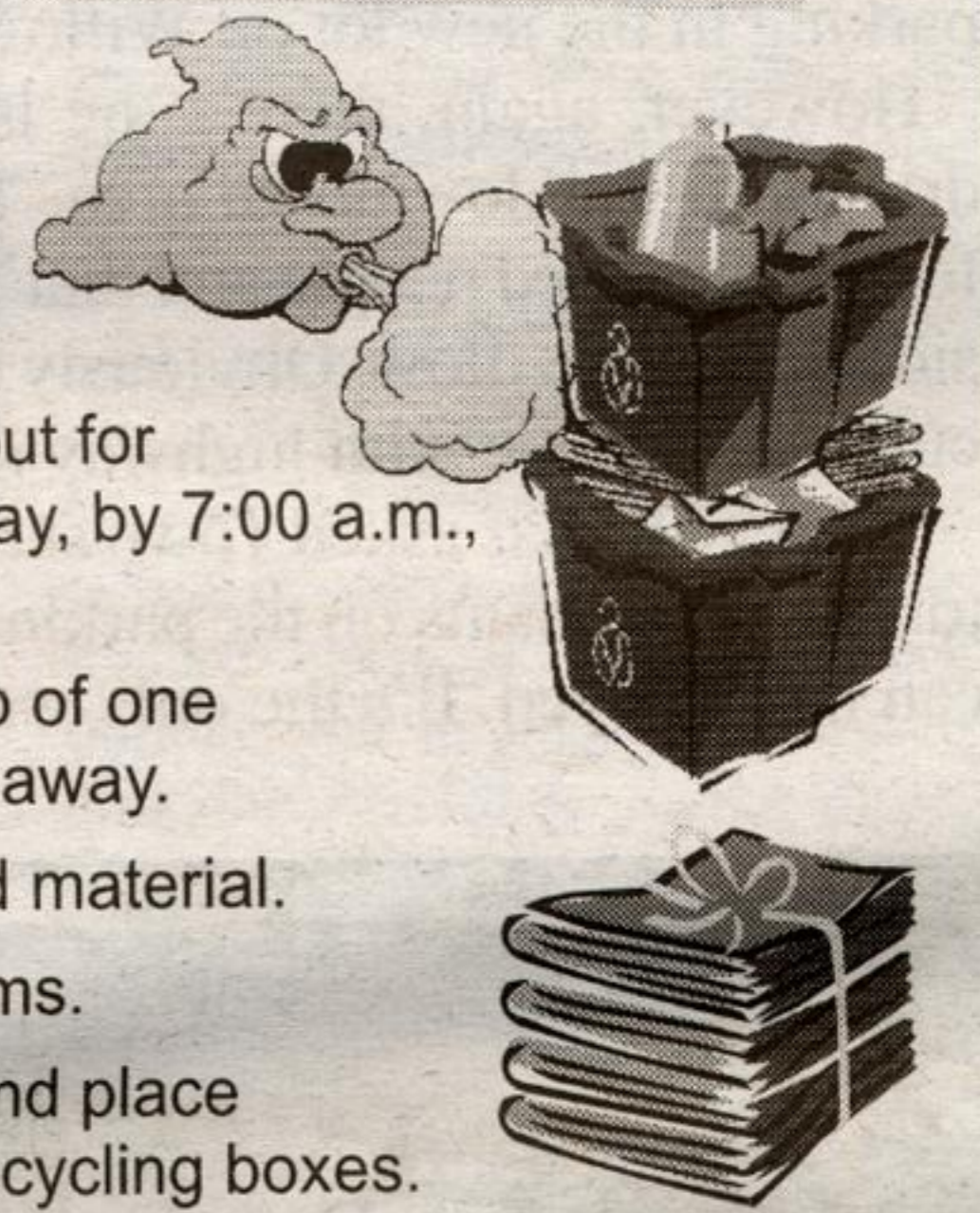

### Help Keep Halton Beautiful Blue Box Recycling Tips

You can help reduce litter with some simple steps to prevent your recyclables from taking flight on windy days. Please ensure your blue box materials are placed curbside in a secure manner.

- On windy days, place your blue boxes out for collection on the morning of collection day, by 7:00 a.m., instead of the night before.
- If possible, stack your blue boxes on top of one another to prevent papers from blowing away.
- Fill boxboard boxes with other boxboard material.
- Place heavier items on top of lighter items.
- Flatten and tie large cardboard boxes and place securely underneath or between your recycling boxes.



### NOTICE OF COMMENCEMENT

#### Class Environmental Assessment Retirement of Tenth Line Well Facility Georgetown Water Supply System Town of Halton Hills, Region of Halton

The Regional Municipality of Halton has initiated a Class Environmental Assessment (EA) to retire the Tenth Line municipal water supply well facility. The Tenth Line well was taken out of service in May 1999, as it does not have a sufficient capacity to operate as a municipal supply well. Halton Region intends to retire the process equipment and unused pumping station building. Halton will abandon the Tenth Line Well as required by the Ontario Ministry of the Environment (MOE) under Regulation 903 of the Ontario Water Resources Act.

A water facility that was subject to the Class EA process for its establishment is also subject to Class EA requirements for its retirement as described in the document entitled Municipal Class Environmental Assessment (Municipal Engineers Association, June 2000). The Class EA for the Tenth Line Well Facility Decommissioning will be conducted in accordance with Schedule B of the Municipal Class EA process.

Input from interested stakeholders is a key component of this project. Halton Region is interested in any comments that you may have concerning this project and will receive comments in writing until November 26, 2004. Subject to comments received from review agencies and the public, the decommissioning activities associated with the retirement of the Tenth Line well facility are anticipated to commence in the spring of 2005.
