Power of Attorney
Commonly Asked Questions part II

Who decides that I am incapable of making decisions about health treatment?

Health practitioners cannot treat you without your consent. If they decide that you are incapable of making decisions about your treatment, then they must get the consent of your substitute decision-maker. This means that your attorney cannot make treatment decisions for you unless a health practitioner concludes that you are incapable of making them yourself. There are many different types of health professionals; for example, doctors, nurses, dentists, physiotherapists, psychologists and psychiatrists, to name only a few.

Who decides that I'm incapable of making decisions about personal care assistance services in a long-term care facility? Or about entering such a facility?

In both cases this is up to an "evaluator". An evaluator must be a nurse, doctor, psychologist, social worker, physiotherapist, speech language therapist or audiologist. Your attorney cannot make these decisions unless an evaluator finds that you are incapable of making them yourself.

How will my attorney make decisions for me?

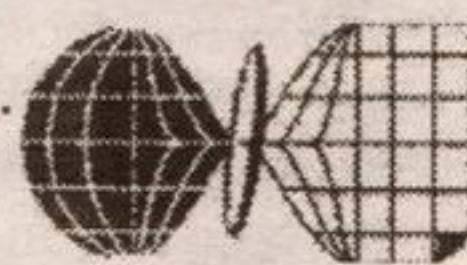
If while you are capable, you give instructions or express wishes about your personal care, your attorney must follow these instructions or wishes.

If your attorney does not know of any instructions or wishes, or you did not give any, he or she will make decisions based on what seems to be in your best interest. To do so, he or she must consider your values and beliefs and even the wishes you expressed after you became incapable. However, your attorney can override these later wishes if he or she believes that this is in your best interest.

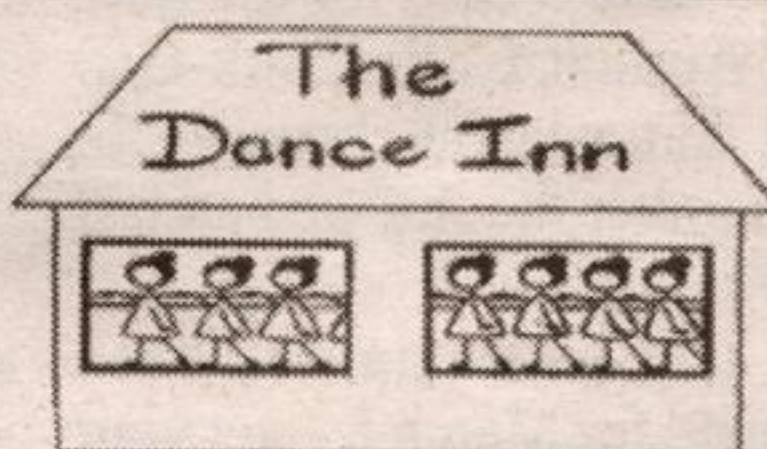

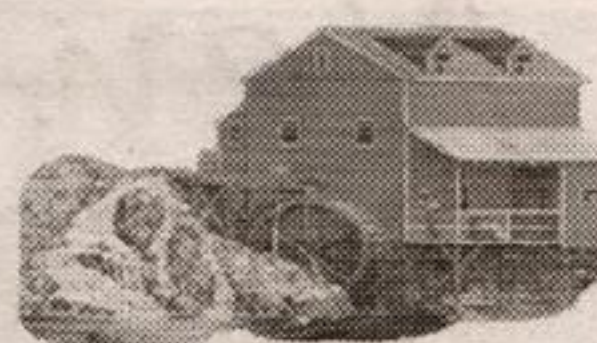

Eden Mills gun club noise debate

A group of Eden Mills residents met at the Eden Mills Community Hall on January 25 to discuss concerns over the Guelph Rod and Gun Club and the noise it produces. They first met last March to determine if there was a common community concern. Approximately sixty people attended that meeting and it was decided that there was in fact a common concern. A steering committee of four people was elected. Their mandate was to take these concerns to the Guelph Rod and Gun Club in hopes of negotiating an amicable solution. The committee suggested reduced hours, in particular closing Sundays so residents could have that day free of gunshot noise. Nothing came of these requests. The committee asked Guelph/Eramosa Township Council to get involved. Mayor Clint Martin and Councillor Chris White contacted the club and asked

them to "come to the table" to negotiate.

As a result, five members of the Gun Club including the president, Borden Zazinsky, attended the meeting on January 25. Council remains neutral but offered their offices and a member of staff to mediate negotiations. The Gun Club representatives agreed to take this idea back to their members for discussion. The concerned citizens group has suggested changing the dusk closing time for the outdoor range to an actual hour. Mr. Tim Laing, a member of the steering committee, said he and other residents have heard the shots well after dark. They also proposed to council that they enact a new by-law that deals specifically with noise from sport shooting clubs. The Gun Club is looking into ways to muffle the sound from the indoor range. Councillor Teressa Gibson-Smye and the township's Manager of Property and Leisure Services, Brad Roelofson, attended the meeting.
