Liberal

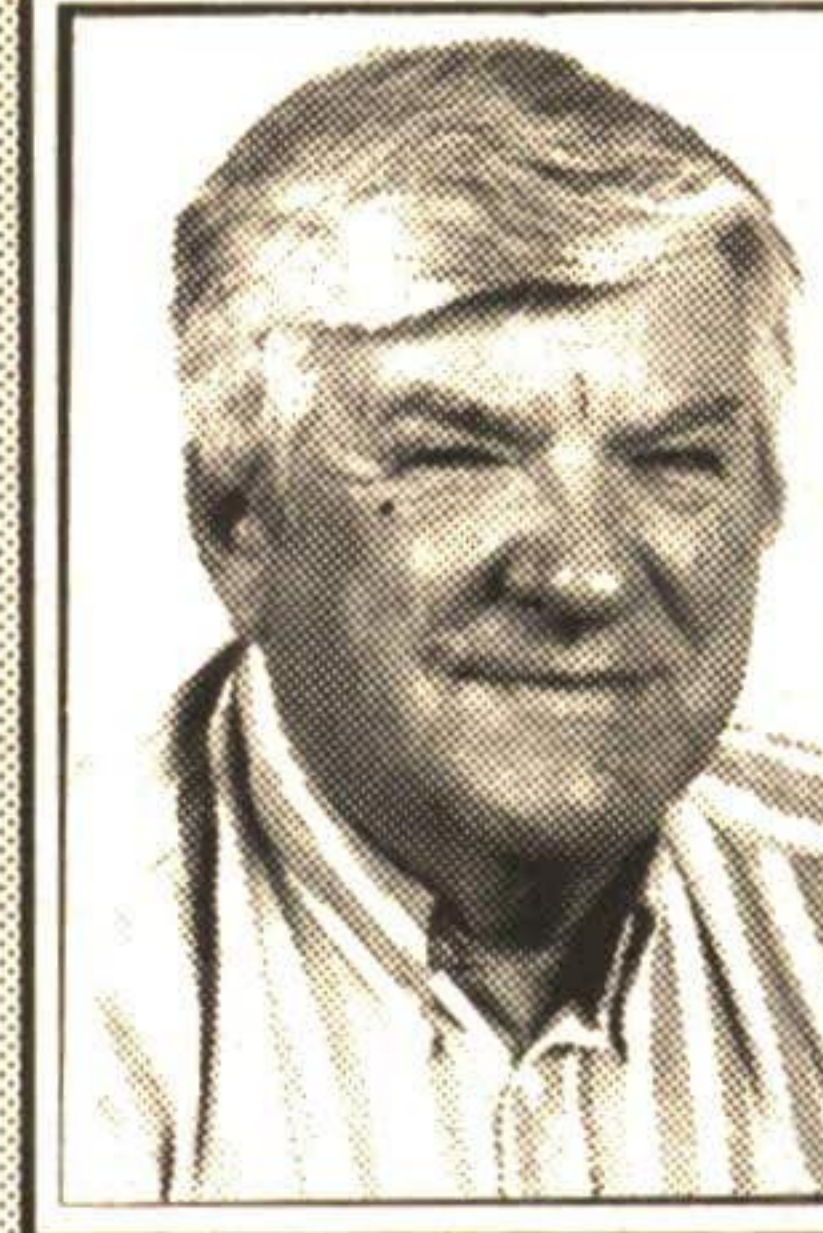

REGION OF HALTON CLASS ENVIRONMENTAL ASSESSMENT ADDITIONAL WATER SUPPLY FOR THE GEORGETOWN URBAN AREA NOTICE OF COMPLETION OF MASTER PLAN

In order to serve planned growth in the urban areas in the Georgetown Urban area (including Norval, Glen Williams and Stewarttown), the Region of Halton is proposing to establish new municipal water wells for future water supply. The recommendations of the Master Plan are to seek full capacity of Test Well 22 (Lindsay Court) and then, stage the implementation of the following sources in order to increase the Georgetown water supply over the next sixteen years:

- Test Well 15 (in the vicinity of 8th Line and 15th Sideroad)
- Huttonville Well (Mississauga Road and Embleton Road, Brampton)
- If necessary, Sixth Line Well (in the vicinity of 6th Line and 15th Sideroad)

These projects are being planned in accordance with the **Class Environmental Assessment for Municipal Water and Wastewater Projects**. The proposed new water wells are **Schedule C** projects under Class Environmental Assessment for Municipal Water and Wastewater Projects.

The Region of Halton has prepared a Master Plan in accordance with the Class Environmental Assessment which contains the documentation required for Phases 1 and 2 of the proposed projects. Subsequent detailed study of each proposed project will be required including public notification and public meetings. Environmental Study reports will be required by the Class Environmental Assessment prior to any detailed design and construction taking place.

Interested persons should provide written comments on proposed projects to the Region of Halton on the proposed projects within 30 calendar days from the date of this notice. Please provide written comment to Ms. Joan Eaglesham, Regional Clerk within 30 calendar days. If concerns regarding a project cannot be resolved in discussion with the Region of Halton a person may request that the Minister of Environment and Energy "bump-up" a project to an individual environmental assessment. "Bump-up" requests must be received by the Minister at the address below by June 28, 1995. A copy of the "bump-up" request shall be sent to the Regional Clerk. If there is no "bump-up" request received by June 28, 1995 the Region of Halton will proceed to Phases 3, 4 and 5 of the Class Environmental Assessment process for the sources outlined in the Master Plan.

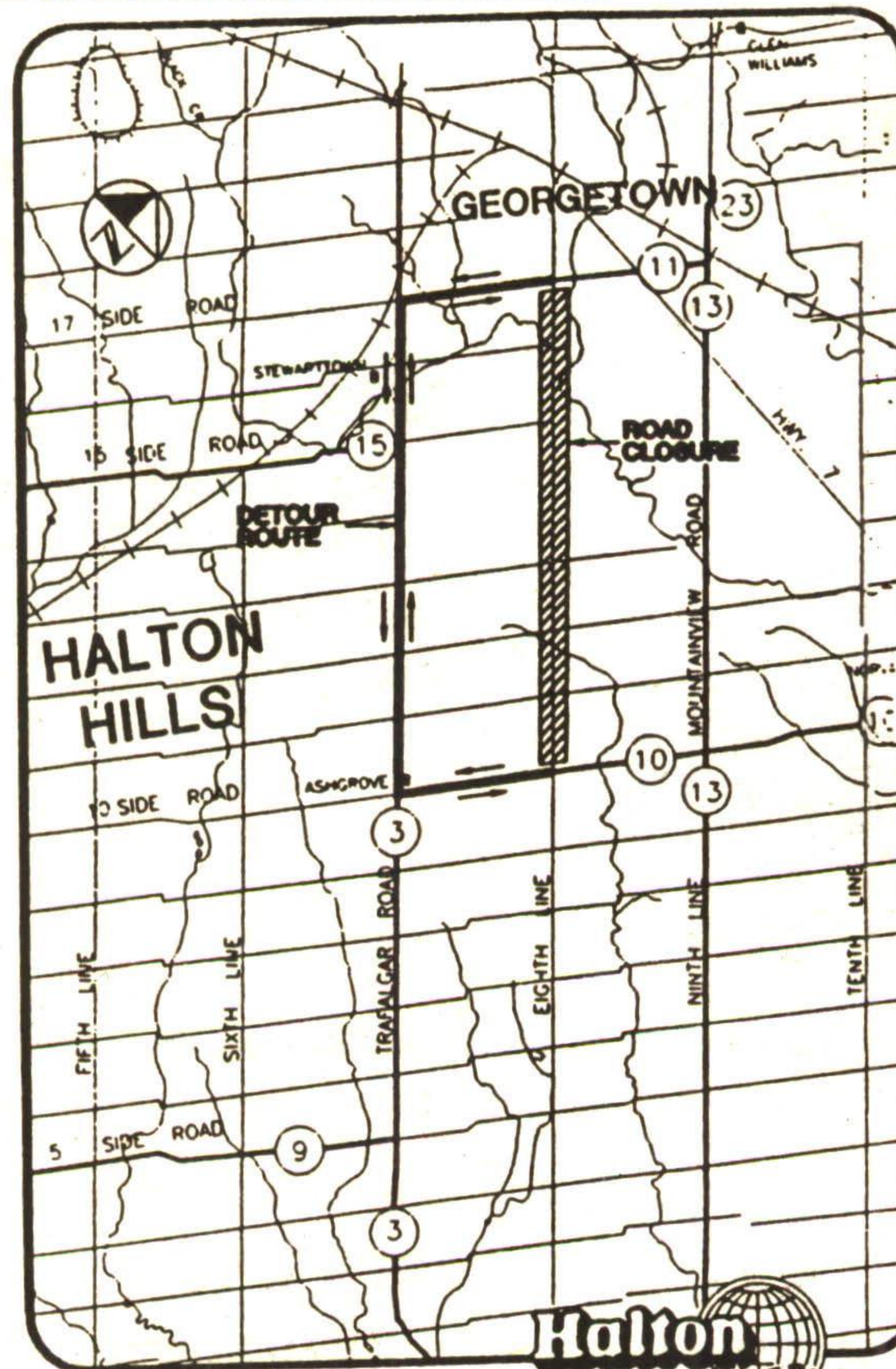

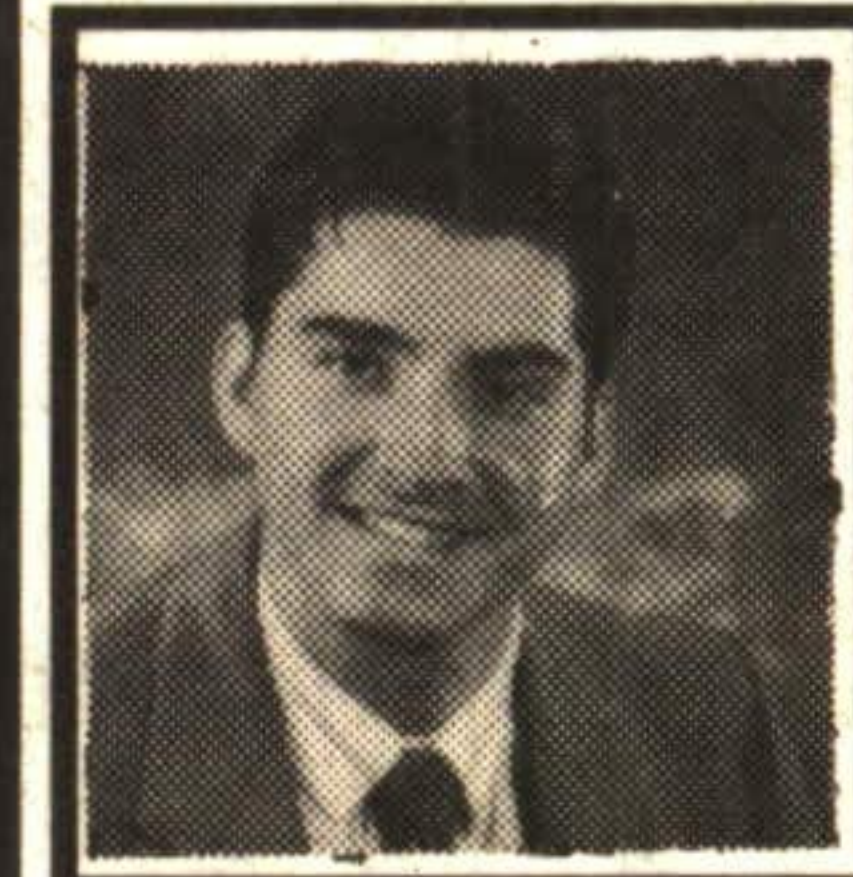
Traffic will be detoured as illustrated below:

... Lend Me Your Ears

New information on how we hear, combined with the explosion of new technology and the entry of computers into the area of identification and rehabilitation have made help available for all with hearing loss.

IMPROVED AUDIOLOGICAL IDENTIFICATION
With recent advancements it is now possible to perform comprehensive testing to determine:

- if hearing loss exists
- the amount and nature of the hearing loss
- the benefits that are possible through the available treatments

Examples of the newest breakthroughs in identification techniques are:

- **AUDITORY BRAINSTEM RESPONSE (ABR)** testing - for use with difficult-to-test populations and for medical diagnosis of auditory disorders. The ABR test can be performed on individuals of any age, even the youngest infant. There is no longer any reason to delay referral of infants for hearing evaluation because they are "too young to test."
- **IMMITANCE TESTING** - for objective and complete identification of middle ear disorders and assessments of the nerve function of the ear.
- **SPECIAL AUDITORY TESTS** - to identify the exact location of the auditory impairments.
