Halton slams corruption cops, wants compensation

Regional council is demanding the province reimburse the \$150,000 Halton spent on legal fees to defend former regional chair Peter Pomeroy from charges of corruption.


Councillors also want the provincial government to scrap Project 80, the joint police task force which investigated Pomeroy, and set up an independent review of Project 80's activities.

"I don't think what we're dealing with here is a question of watchdog — it's a question of attack dog," said Burlington regional councillor Ralph Scholtens,

municipal investigating corruption.

"The people who have brought these charges against Mr. Pomeroy have done him a tremendous disservice, have done all of us a tremendous disservice. I think we need to be reimbursed," said Scholtens, who introduced the motions to be sent to the provincial government.

Pomeroy, 56, who was recently acquitted on four charges of sought to substantiate a theory, I breaching the public trust and accepting bribes, appeared before regional council with his lawyer, Brian Greenspan on

Wednesday afternoon. The Region agreed last fall to pay his legal fees, provided

he was acquitted on all charges. Greenspan told councillors that the court cases provided vindication of Pomeroy.

"(Justice James Carnwath) makes it clear that Mr. Pomeroy is not only not guilty, he is innocent," said Greenspan.

"The investigation began with a conclusion and intended not to neutrally investigate but

suggest in a bullying manner." The individuals responsible for spreading the rumors and innuendo which led to his investigation should be held responsible for the Region's costs, Pomeroy indicated.

On a personal level, "I have no desire to chase these people for whatever reason. I want to get on with my life," he said.

But he urged council to consider civil action against the individuals, who weren't publicly named, to recover taxpayers' money.

Afterwards Pomeroy told reporters, "I honestly believe (council) has an obligation to (undertake civil action). I feel very strongly about this.

"In my opinion it would be the biggest crime of all if these people weren't brought to justice."
