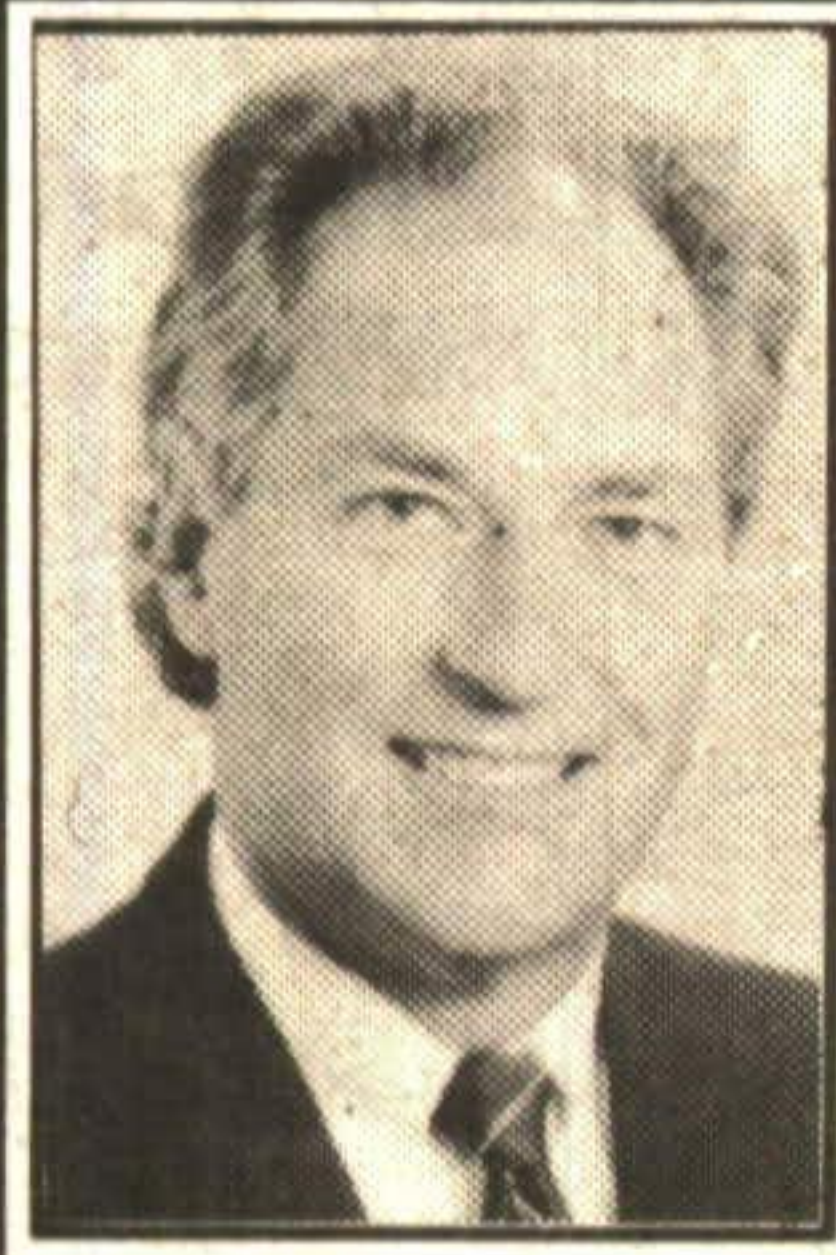


# Candidates respond to Halton North issues

**Question: How would your party's tax plans affect Halton Hills?**

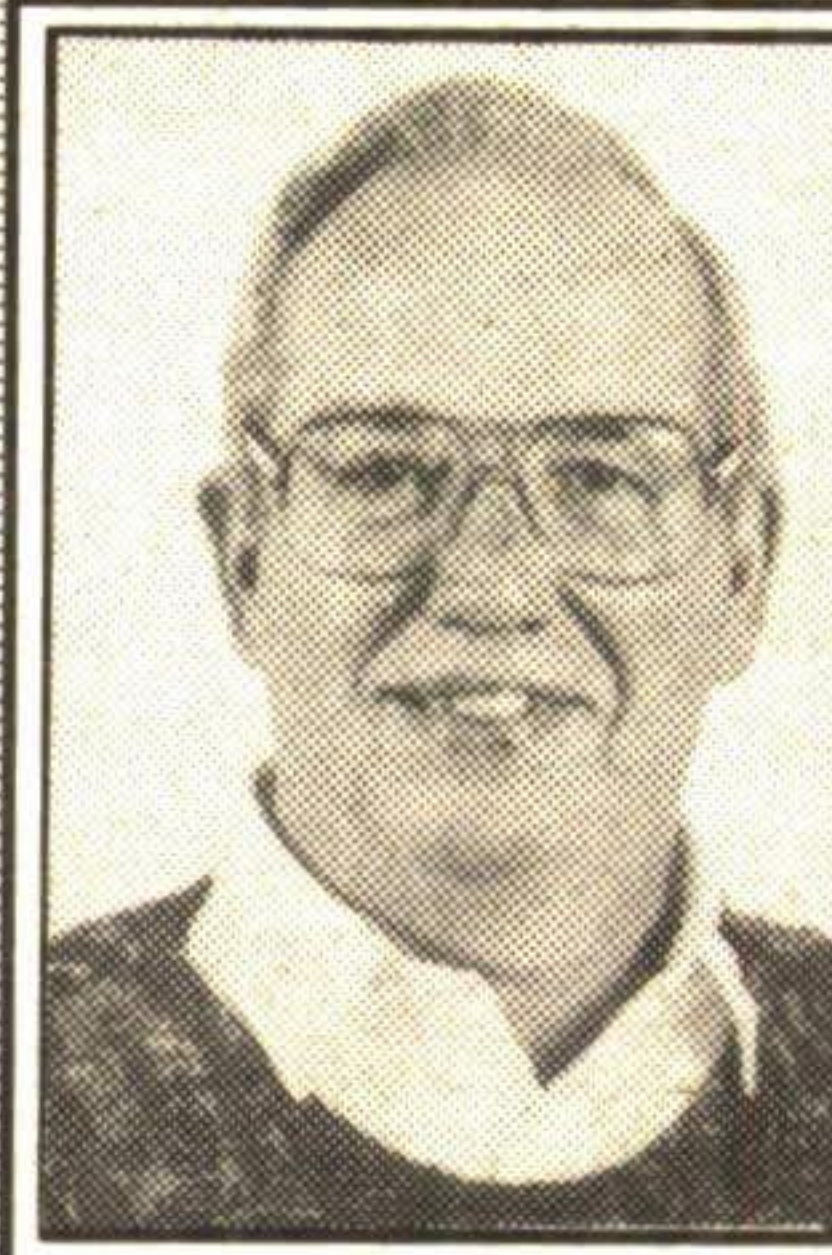
**Ted Chudleigh**  
*Progressive Conservative*

Currently Halton North residents are paying at a rate of 58 per cent of their federal tax to Ontario. In the first year of our government we will cut that rate to 48 per cent then to 43 per cent in the next year and finally to 38 per cent in the third year. This will give Ontario the lowest personal income tax rate in Canada. It would be irresponsible to make this cut without decreasing spending even more.



**Noel Duignan**  
*NDP*

The Bob Rae government did not raise income taxes in 1994 or in 1995. When facing a possible \$17 billion deficit two years ago, the NDP increased personal income tax, but we did it fairly. On average, Ontario families' annual taxes have increased 1.2 per cent. The top 10 per cent of earners have paid for 40 per cent of the increases, and income taxes have gone down for 270,000 low income Ontarians.



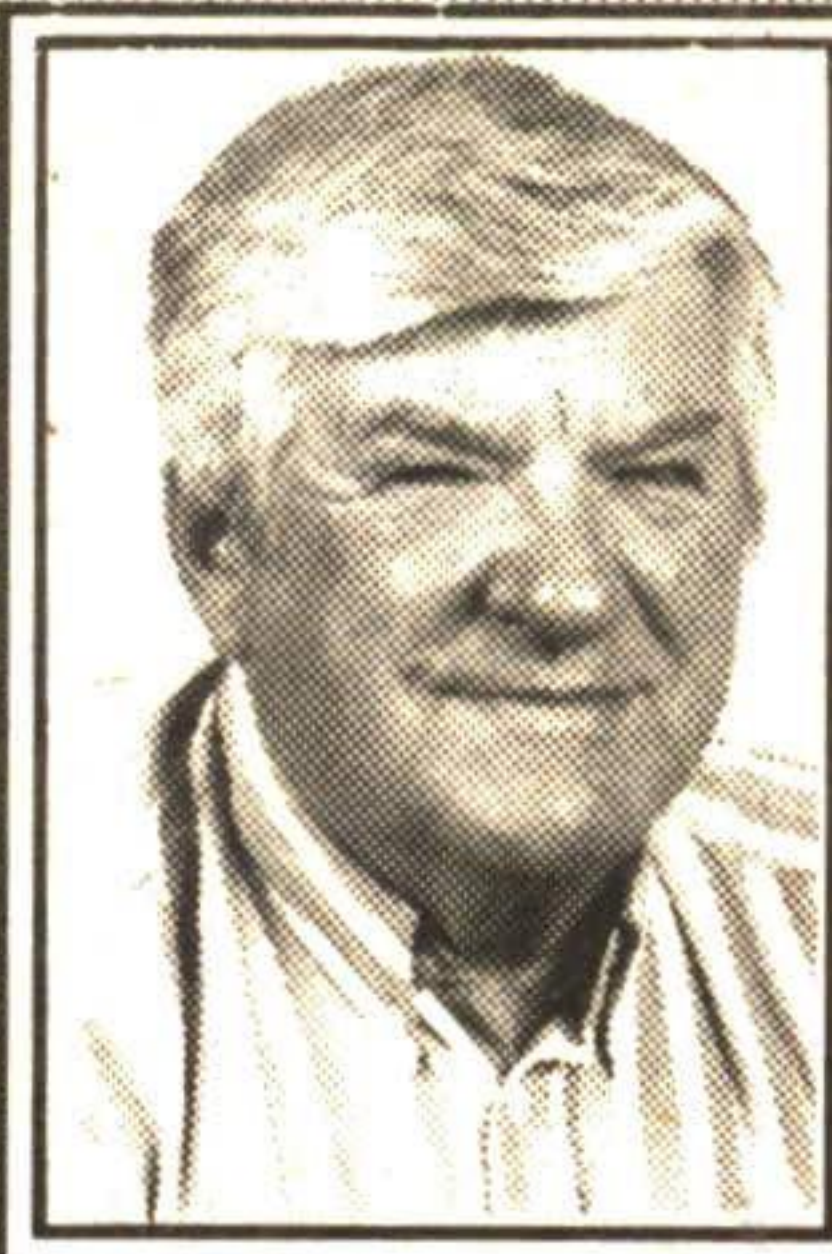
**Walt Elliot**  
*Liberal*

Halton Hills taxpayers have hit the tax wall. They do not want any tax increases. The Liberal Action Plan has a modest 5 per cent overall tax cut in it. Tax increases will not happen. We will also target unfair taxes such as the 5 per cent insurance premium tax and remove them.



**Alex McKee**  
*Family Coalition Party*

Through the voucher system in education we will save \$4 billion in annual education taxes. In that Ontario contributes \$8 billion to education by way of property taxes we will be able to decrease property tax by 30 to 40 per cent. This will create strong growth in the housing market and make home ownership more a reality than a "promise."

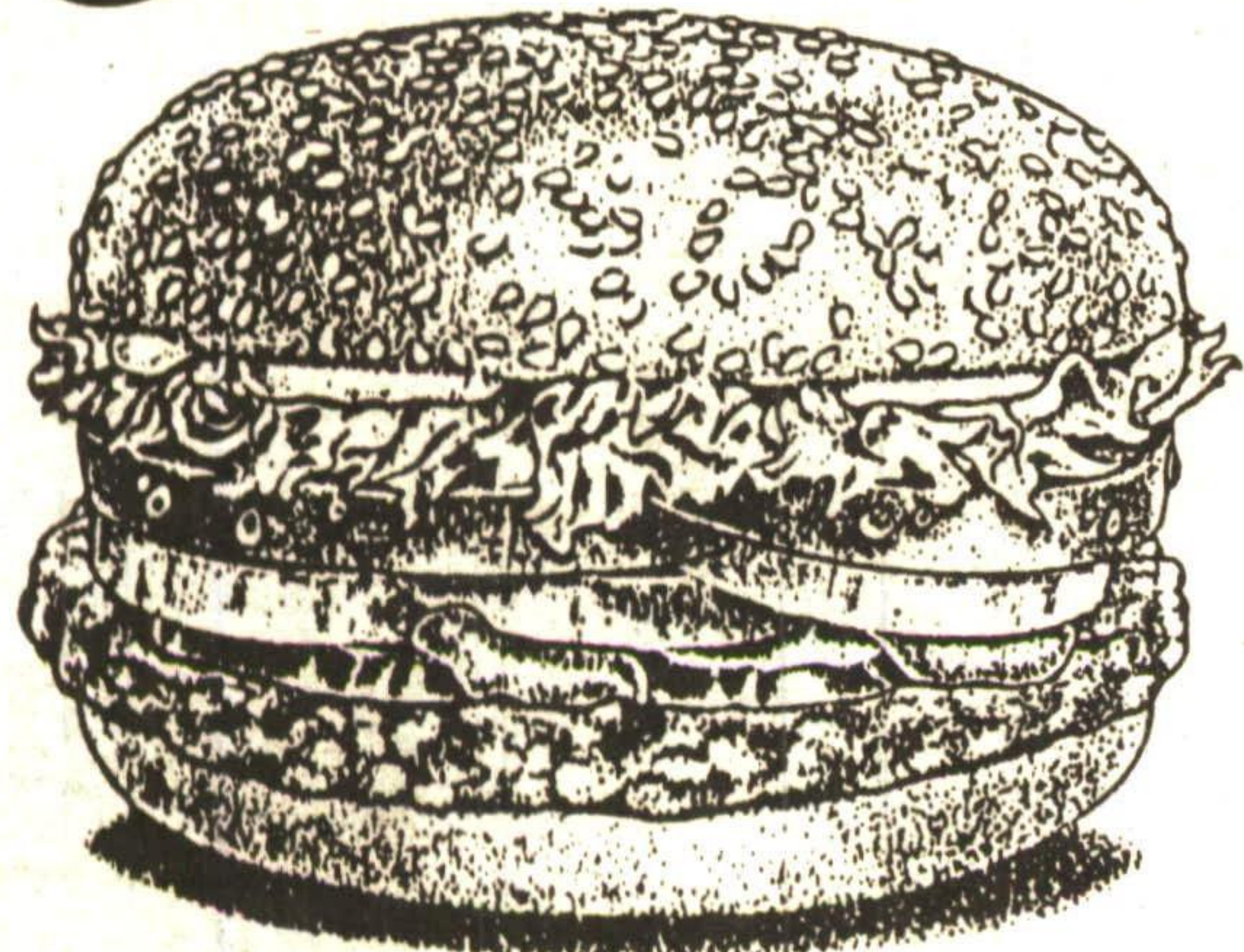


**John Shadbolt**

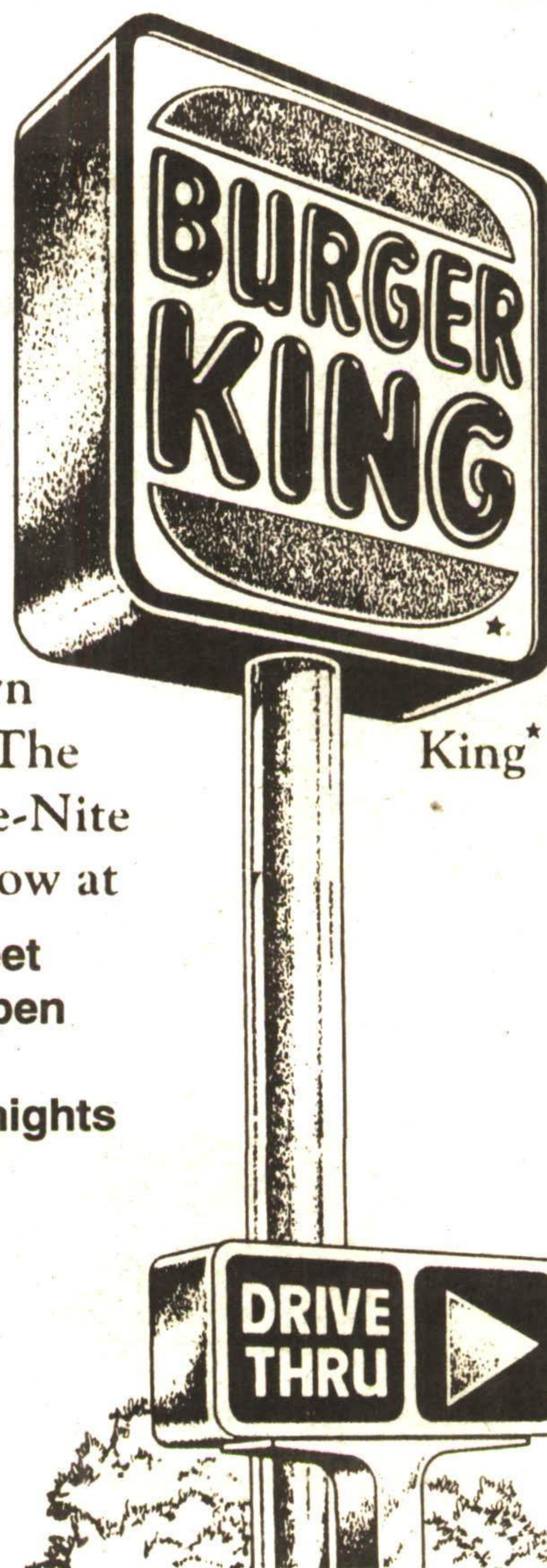
