

NOTICE OF OVERNIGHT PARKING RESTRICTION



Uniform Traffic By-Law No. 84-1 prohibits parking: 2:00 a.m. - 7 a.m. (daily) November 15 to April 15

on all streets under the jurisdiction of the Town of Halton Hills, unless authorized signs indicating otherwise are specifically posted. Motorists are reminded that By-Law No. 84-1 also prohibits the parking of a vehicle on all Town or Regional Roads for longer than 3 consecutive hours at any single location, unless otherwise specifically posted.

On-street parking hinders snow clearing and other road maintenance operations. Your cooperation is requested. Please comply with the requirements of this By-Law.

AUTHORITIES MAY HAVE VEHICLES TICKETED OR TOWED AWAY AT THE OWNERS EXPENSE.

SNOW CLEARING

The placing or pushing of snow or ice onto roadways or cleared sidewalks will obstruct or encumber vehicular and pedestrian traffic. Such action is prohibited by the Town's Obstruction, Encumbering or Fouling of Highways By-Law No. 90-68.

Improper snow and ice clearing can be a serious hazard to motorists and pedestrians. Your cooperation is requested. Please comply with the requirements of this By-Law.



Mr. Ron Noble, Chief Executive Officer,

Georgetown and District Memorial Hospital, I recently spent time in Georgetown Hospital and wish to express my gratitude. From the moment my daughter called for an ambulance until I returned home some ten

days later, I received the utmost in compassionate, professional care. Within minutes of calling 911, the

ambulance arrived, took vital signs, and I was on my way. While I remember little of the ride, my daughter tells me I was rushed into emergency where the nurses quietly calmed and reassured me that I was in good hands as they hooked me up to monitors within moments.

Luckily, Dr. Browning was in the hospital and was able to quickly diagnose a heart attack and start treatment immediately.

I was settled in intensive care within a couple of hours where I spent the next five days under the watchful care of a marvelous, caring team of nurses.

My heartfelt thanks especially to Jean and Josie, who were never too busy to attend to my smallest need and whose compassion and keen sense of humor were as important to my sense of well-being as were the necessary IV's, pills and tests.

I finished my last few days in hospital in a semi-private room with a woman who had suffered a debilitating stroke. I watched as the nursing staff assisted her in many ways, while at the same time encouraged her to attempt small tasks to begin the long road back to independence.

It is possible that I would not be writing this letter today, had it not been for every member of the Halton Hills medical team doing an outstanding job.

While I had heard that Georgetown was a small hospital, perhaps unable to provide the essentials that the larger urban hospitals take for granted, I can only say that I have nothing but the highest praise for the institution and its doctors and nurses who are working under stressful cutbacks but whose dedication to their profession does not allow them to compromise their standards.

My experience there also gives me one more reason to be happy that my family has chosen Halton Hills for our new home!
