# A good start

Under the proposed Tory reform, rent controls will be eliminated on new buildings and on vacated apartments. When a tenant moves, apartment rents could be increased to market values.

For current tenants, landlords would be limited to rent increases of 4 per cent, but they would also be allowed to pass on repair bills and increases in municipal taxes and utility bills.

The current rent registry would be replaced with an new system to deal with landlord and

tenant problems.

The proposed legislation would protect tenants from "unfair or double-digit rent increases, evictions and harassment" through a new enforcement unit.

The intent of the reform is to stimulate construction in rental housing, which has been stagnant for so many years. Landlords claim it's because rent control hampers their ability to pass along "real" costs to the tenants.

The reform is bound to be contentious — and bring out the vocal extremes on both sides.

No matter what, the province must perform a balancing act with this legislation by providing landlords with an incentive to do business while at the same time protecting the tenant from unfair price increases.

This is a good start.
