- Mayor Marilyn Serjeantson mentioned to colleagues that Halton Hills should consider soon whether it wishes to become involved with the possible Metro Toronto bid for the Summer Olympics of 2008. She suggested that Halton Hills may be a good venue site for equestrian competition.

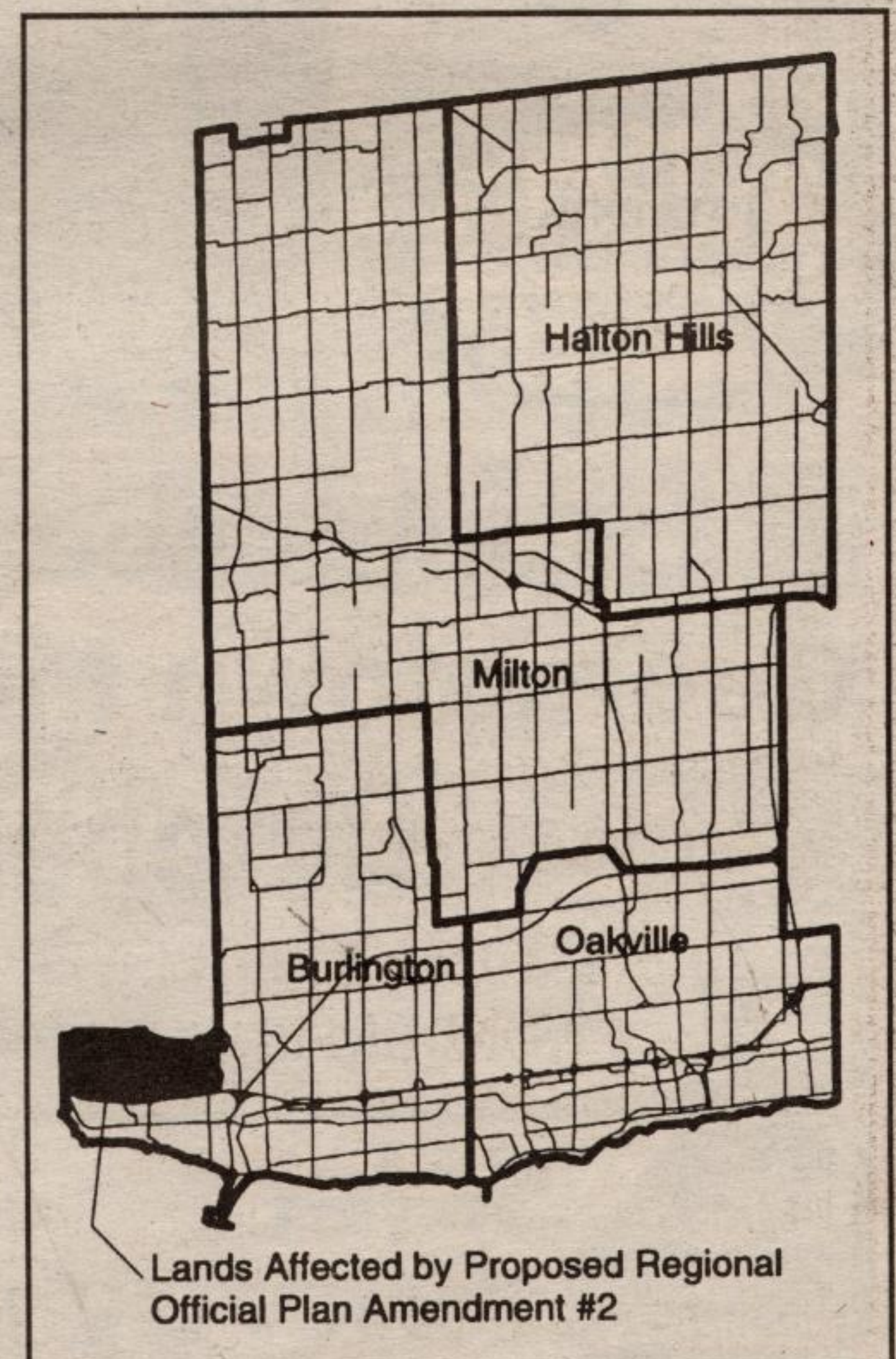
Purpose Of Amendment: The purpose is to implement the recommendations of the *North Aldershot Inter-Agency Review Final Report* (May 1994). This proposed amendment affects lands illustrated on the map below and proposes to redesignate certain lands in North Aldershot from Parkway Belt West Plan designations to "North Aldershot Urban Separator Area" and other designations. It also sets out policies to guide land use in the "North Aldershot Urban Separator Area" designation and deletes certain lands from the "Parkway Belt Special Study Area".

Note: If you wish to be notified of the adoption of the proposed Official Plan Amendment, you must make a written request to the Regional Clerk at the above address. If a person or public body that files a notice of appeal of a decision of the Regional Municipality of Halton in respect of the proposed Official Plan Amendment does not make oral submissions at a public meeting or make written submissions to the Regional Municipality of Halton before the proposed Official Plan Amendment is adopted, the Ontario Municipal Board may dismiss all or part of the appeal.

Related Applications: The City of Burlington is also proposing an amendment to the City of Burlington Official Plan for lands known as the East and West Sectors of North Aldershot (City File: 505-03-131). Lands known as the Central Sector of North Aldershot, includes lands subject of a City of Burlington Official Plan Amendment (City File No. 505-02-197), an amendment to Parkway Belt West Land Use Regulation 482/73 (Minister's File: 24-ZO-041-9203), zoning by-law amendment (City File 4000-841), and two plans of subdivision (Region File No.'s 24T-94010/B and 24T-94012/B), and are the subject of an Ontario Municipal Board hearing for which a decision is pending.

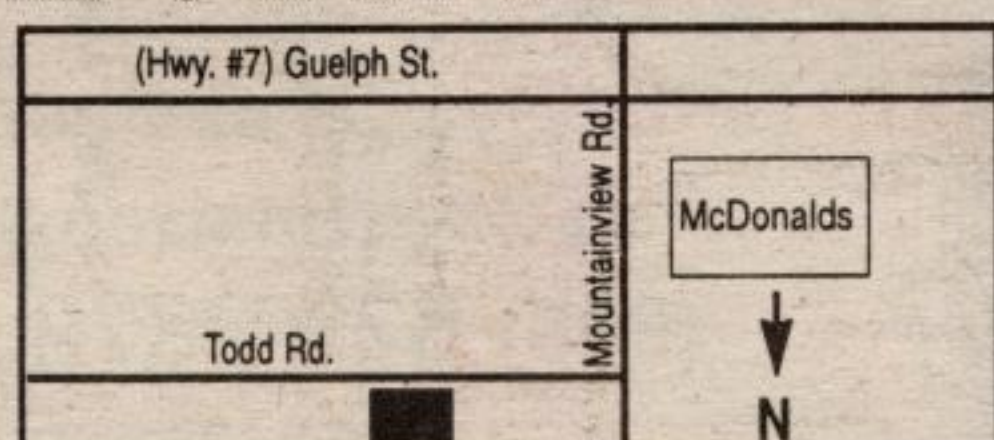
