The Ontario government's decision to allow Boxing Day shopping this year is welcome I news and will finally end the usual open-close nonsense we see every year.

By amending the Retail Business Holidays Act to allow stores to legally open Dec. 26 the Tories are

simply giving the people what they want.

Thank you for the kind words in your editorial in this weekend's edition (Nov. 10). However, I would like to voice my disappointment in your editorial cartoon in the same paper.



I would like to thank you for distributing the bags in your newspaper for the food drive.


