
Business break-in



Provincial funding to town 'more than expected'

The Town of Halton Hills got the official word last I Friday it will receive \$976,328 in transfer payments from the provincial government for 1997 through its Municipal Support Program.

Town treasurer Andrew Koopmans said the grant is a little bit more than had been expected, but almost 36 per cent less than the town received through the program last year. The 1996 transfer payment was 34 per cent less than the 1995 provincial funding.
