## Future meeting needed to discuss problems of heavy truck traffic

Fourth Line/17 Sideroad residents, United Aggregates Limited (UAL) and members of town council will meet in the near future to discuss the ongoing problems of heavy truck traffic.

The public information session was included in council's approval of an operational review of the Fourth Line from 17 Sideroad to Hwy. 7 and 17 Sideroad from Trafalgar Rd. to the Fourth Line. As well, engineering staff was directed to begin a design and construction of a right turn acceleration lane at the UAL entrance on the Fourth Line (at UAL's expense) — in conjunction with a Fourth Line reconstruction project done by the Town in 1999.

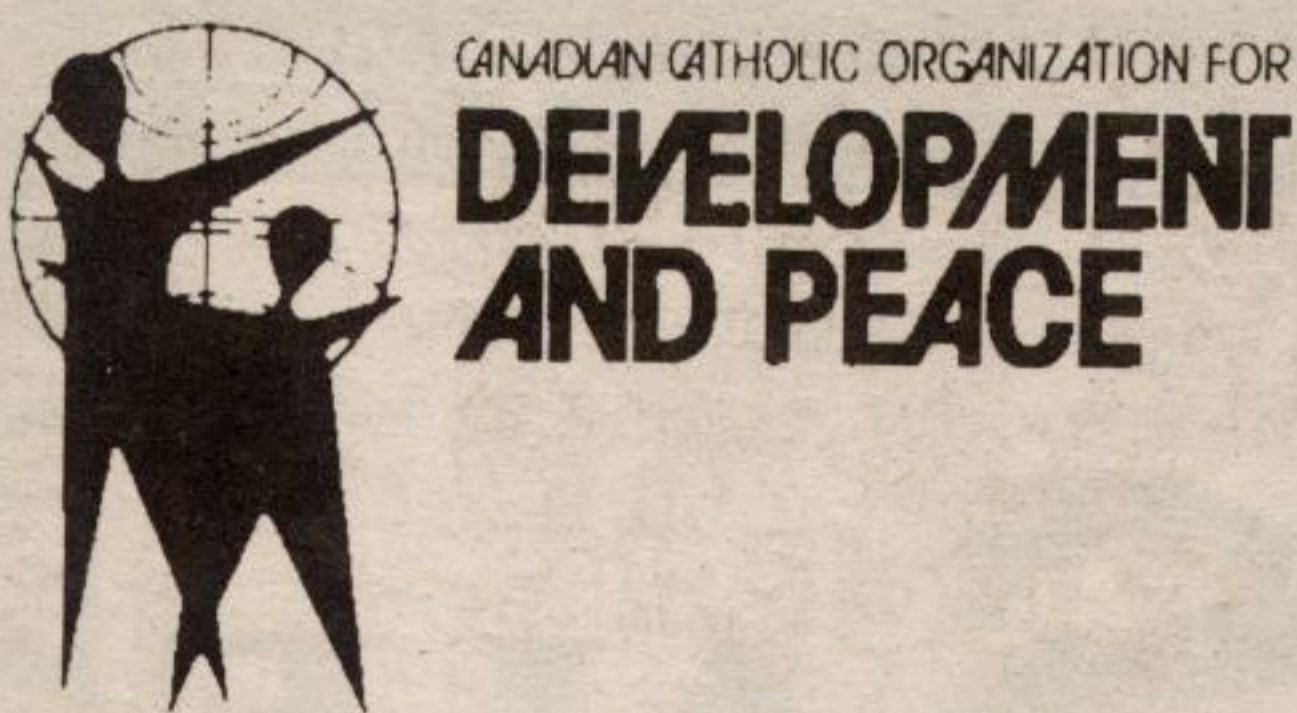
Last Monday night, 4th Line/17 Sideroad resident Doug Poyntz, representing the area residents appealed to council to ban truck traffic on the weekends, from 6 p.m. Friday to 6 a.m. Monday. Barring that, they wanted the same restrictions as Maple Ave. residents got— 8 p.m. to 6 p.m. daily, noon to midnight on Saturday, and all day Sunday. Currently trucks using the Fourth Line/17 Sideroad route are banned from 6 p.m. to 6 a.m. night— staff recommends that the ban remain as is.

Poyntz using a town staff's report says weekend truck traffic has increased by 23 per cent.

"It's that type of increase that concerns the residents of Fourth Line," Poyntz said, suggesting that the gravel trucks could use alternative routes.

But UAL executive vice-president Bill Burkart who also attended Monday's meeting, told councillors alternative routes on the weekends, would create added expense for UAL and the truck drivers, could force UAL to lose future contracts, and would only shift the problem to other roads and other residents.

No date was set for the public information forum.
